Minutes from the April 1, 2024 Meeting

Michael discussed the following with our group:

- The Westside Battery project is one step closer with groundbreaking expected this fall and completion expected by December 31, 2025; the process takes longer with affordable housing.
- ARPA funds are almost gone; there is approximately \$1.5 million left of the \$15 million initially available). The funding must be allocated by the end of 2024 for completion of projects by the end of 2026. Funds are/will be used for blacktop/road repairs, Department of Public Works and Police Department repairs, the Wausau airport, and the Parks and Recreation Department.
- Wausau is accepting Section 8 housing applications until April 12th; preference is currently given to unhoused persons.
- Michael discussed the on-boarding of City Council members after the upcoming election. There will be an evening retreat for Council members and the League of Municipalities will also have additional on-boarding information.

Ann had several items for our group:

• Ann reminded everyone to be sure and vote tomorrow. There will be at least 10 new County Supervisors; 10 current Supervisors are not running for re-election.

- The Aging and Disability Resource Center (ADRC) is expected to move to the Lakeview Campus (hopefully in April).
- The County requires a 2 day on-boarding session for all County Supervisors (new and current). The Wisconsin County Association also has on-boarding information available for them.

There were several general questions/items from the group.

- The little libraries on the corner of East Thomas and Grand Avenue will remain there for now but the intersection will require water main work in the future.
- TID 6 will be closing soon, so approximately \$3.5 million to go towards affordable housing.

Chief Matthew Barnes and Officer Luis Lopes Serrao spoke to us about constructing fencing around the Police Department parking lot.

- Chief Barnes explained the Police Department has experienced numerous issues with the parking lot for a number of years. The unfenced parking lot is considered public property while a fenced area is not sometimes resulting in confusing interactions between officers (both on and off-duty) and the general public. Fencing may also help route members of the public to the appropriate entrance for the Police Department.
- Officer Lopes Serrao has been attending a command college course which includes completing a project. He looked at a variety of things that could be done and selected fencing the Police Department parking lot. He had to research zoning, engineering, finance and city council requirements that would impact project decisions. A black chain-link fence would cost about \$35,000 and is not allowed because of zoning regulations; an ornamental fence (similar to the one surrounding Marathon Park) could cost as much as \$200,000. Options are still being explored in order to ensure the best combination of looks, cost, effectiveness and compliance to all codes. Fence proposals must be given to Finance and the City; ARPA funding is one possible option for the fencing.

Officer John Shear distributed and discussed the Briefing Sheet. Officer Shear is originally from Medford and was hired in October, 2019 and started in the Community Resource Units in March of this year. There wasn't much activity in our neighborhood to report for the month of March.

Clean it Up Wausau (large item drop-off) will be held Friday May 17 and Saturday May 18 from 9:00 AM – 5:00 PM. You must show proof of City of Wausau residency. Any questions, please call City of Wausau Department of Public Works 715-261-6960. Office hours are Monday -Friday from 7:00 AM – 3:00 PM.

Examples of FREE disposal items:

- Furniture: tables, chairs, sofas, dressers, mattress/box springs, stoves, washers, dryers, dishwashers, microwaves, grills.
- Yard Equipment (gas and oil removed): snow blowers, lawn mowers, weed trimmer, edger, rototiller
- Scrap Metal

Examples of Items with a disposal FEE: ***CASH ONLY***

- Tires:; up to 20" \$5 (each), over 20" \$10 (each)
- Broken TV's: \$0.65/1b
- All Electronics: all computers, faxes, printers, non-broken TV's, small appliances like coffee makers and vacuum cleaners, stereos, almost anything with a cord) \$0.45/lb

• Appliances: dehumidifiers, air conditioners, refrigerators, freezers - \$25 (each)

UNACCEPTABLE ITEMS

- General Miscellaneous: light bulbs, smoke/CO detectors, batteries, paint, chemicals, waste oil, antifreeze, remodeling waste (insulation, fiberglass, etc.), roofing material, lead, fertilizers, pesticides or herbicides, compressed gas cylinders, explosives
- Medications: Drop Off at Local Police Department
