In compliance with Chapter 19, Wisconsin Statues, notice of this meeting was posted and transmitted to the Wausau Daily Herald in the proper manner.

1. <u>Welcome and Introductions</u>

Lynch called the meeting to order at 4:31 p.m.

2. Public Comment

Todd Treu: reiteriated his comments from the previous meeting. Read an email between Bill Bertram (IronBull) and Dave Meurett (WisDOT), that stated the proposed rumble strips would not adhere to state recommendations.

Lynch: read into comments the email from Kevin Lang, Deputy Highway Commissioner, that County Highway was considering safety as well as other factors on where the rumble strips are placed per their safety plan.

3. <u>Approve minutes of May 20, 2024 Meeting</u> Motion/second by Neal/Filtz. Passed unanimously.

4. <u>Discussion and Possible Action: Recommendation to County Infrastructure Committee on the use</u> of Shoulder Rumble Strips on County Highways

Lynch recapped the discussion from the previous meeting regarding this topic and the desire of the committee to have another meeting to develop a recommendation before the County Infrastructure meeting on June 6. Included in the packet are several options for recommendations compiled by staff. Chair Smith provided the start of the recommendation regarding adherence to state, federal, and industry standards.

Neal voiced concern that the ultimate recommendation is carefully worded so not to be poorly received by the County Committee. Gerhards asked Treu if it was still possible to bike over the rumble strips if needed to when avoiding obstructions. Treu noted that it was possible but difficult and prone to lost control.

The committee considered many of the recommendation options, the wording, and additional concerns to develop the recommendation.

Lynch would forward the recommendation to the County Infrastructure Committee, Smith noted he would appear in person.

Motion/Second by Smith/Neal to recommend the following:

"The Wausau Bicycle and Pedestrian Advisory Committee recommends that Marathon County Follow AASHTO, FHWA, and WisDOT guidelines regarding the use of rumble strips on Hwy KK, Hwy X, and Hwy J. The recommendation would be to install 8 inch edge line rumble strips with 12 foot gaps for every 48 feet of rumble strip only on roads that allow at least 4 feet of paved shoulder.

Additionally, we ask that the county create, update yearly, and make publicly available a map of all rumble strips on county highways and indicate the type and width (if paved) of the shoulder.

Additionally, new or reconstructed roads should include shoulders wide enough to meet the guidelines above, to accommodate bicyclists on the shoulder and edge line rumble strips. We recommend that the county involve and include road users and stakeholders in discussion of future projects of rumble strips, including Wausau's Bicycle and Pedestrian and Advisory Committee, Rib Mountain's Pedestrian and Bicycle Safety Subcommittee, and other community stakeholder groups.

Furthermore, we'd recommend minimal use of rumble strips on roads that are signed cycling routes."

Passed unanimously.

5. <u>Discussion: Committee Social Dinner and Gathering after June 24th meeting – hosted by Jonathan</u> <u>Smith</u>

Smith invited everyone to his house for a social gathering after the next meeting. Just a time to connect and get to know one another. Lynch will notice meeting for possible quorum.



STAFF REPORT TO CISM COMMITTEE - January 9th, 2020

AGENDA ITEM

Washington Street / River Edge Trail RRFB

BACKGROUND

At the request of the Bicycle and Pedestrian Committee, the Engineering Department has investigated the possibility of placing a Rectangular Rapid Flashing Beacon (RRFB) at the River Edge Trail pedestrian crossing on Washington Street. See attached for crossing images and pedestrian counts.

The following are the priority criteria for placing an RRFB from the WisDOT Traffic Engineering, Operations & Safety Manual (4-5-1).

- 1. The location is an uncontrolled pedestrian crossing. *Condition met.*
- 2. A minimum volume of 20 or more pedestrians during a single hour (any four consecutive 15-minute periods) of an average day should be met. Young (<12), elderly (>85) and disable pedestrians count 2 times toward volume thresholds. Additionally, seasonal day volumes can be used in place of average day volumes if the crossing is in a known tourist area.

Pedestrian counts from 9/20/2019 indicated peak rate of 21 pedestrians per hour. Condition met.

- 3. A minimum vehicular volume of 1,500 vehicles per day. *Condition met.*
- 4. Maximum of four lanes crossed, unless there is a raised median, in which case it can be six lanes.

Condition met.

5. There exists a minimum of 300 feet between the subject crossing and the nearest controlled pedestrian crossing or intersection traffic control device on the state trunk highway system. Consideration should be given to extending this distance beyond 300 feet if the proposed crosswalk location falls within an auxiliary turn lane for the nearby intersection or if the standing queue from the intersection extends over the proposed crosswalk location.

Nearest controlled pedestrian crossing is 330 feet. Condition met.

 Adequate stopping sight distance exists based on FDM 11-10-5 or greater than 8 times the posted speed limit. *Condition met.*

FISCAL IMPACT

\$10,000

Given that the crossing meets all guidance criteria and an expected increase in use due to nearby development, City Staff recommends placement of the RRFBs.
