

#### **Unhoused Data**

The following graph shows the number of unduplicated<sup>1</sup> guests housed by each organization in the previous month.



#### **Unhoused Data Summary**

In July, data suggests there were approximately 186 unhoused individuals identified in Wausau through various partnering agencies. As indicated in the footnote, 186 is not the true number of unhoused. As of today, organizations do not cross-reference names when coming up with their unduplicated count. This means an unhoused individual may be part of more than one organization's count, thereby inflating the true number of unhoused. An example is provided in the footnote. This number also does not include those individuals who are considered "couch surfing".

<sup>&</sup>lt;sup>1</sup> The numbers reflected do not eliminate duplicates across organizations. For example, a person who stays at The Good Shepherd Shelter and Marathon County jail in the same month will count as 1 person for each organization.

In the graph above, 80 percent of the unhoused sought or received shelter in the month of July, 20 percent of the unhoused were living outside, or in places not meant for human habitation.

The Women's Community data includes crime victims who sought shelter because their home was unsafe. This number reflects both single females (12) and their children (11).


Bridge Street Mission includes individuals who have received shelter after release from jail/prison, drug rehab, or homelessness. In previous reports, the number reported to this committee only reflected a small number of individuals who sought shelter in preparation for being transitioned into the "apartments" on the main level of the building. The number reflected should include all individuals who are housed at Bridge Street Mission, because without this amazing program in our community, 19 (per this month's census) individuals would likely be unhoused in our community.

The Marathon County Jail includes individuals who identify as "homeless" or "unhoused" at the time of booking.

#### **Daily Census**


We are working hard to collaborate with our partner organization to get a handle on shelter capacity in Wausau. It's important to know if we're meeting or exceeding capacity. The Salvation Army is sheltering families at this time, so current shelter capacity for single adults lies solely on Good Shepherd shelter, formerly known as, the Wausau Warming Center, and their total bed capacity is 30, with the ability to expand to 40 when temperatures fall below 15 degrees or above 90 degrees.

## **Good Shepherd Daily Census**



#### **Daily Census Summary**

On average, capacity was at 93 percent for the month of July. The Good Shepherd Shelter was at or over their capacity a total of 8 days in the month of July.

Continued collaboration exists to ensure that the unhoused population have access to services.

We continue to work with our partner organization to learn how many people are turned away each night. In addition to capacity, individuals are turned away for a variety of other reasons. The "turn-away" statistics for the month of July are as follows: The Good Shepherd Shelter = 79

\*It is important to note that The Good Shepherd Shelter does reserve beds for individuals that are working. When individuals do not show for their bed saves, it results in the shelter not reaching their 30-bed capacity for the night (as shown in the graphed data)

In July the number of individuals needing a bed save due to employment was 14. The range was 1-7 people needing a bed per night, with a 15 percent of guests working the month of July, who were seeking shelter. The median number of people needing a bed/night was 3.

#### **Outreach Update**

In July, outreach resulted in 4 individuals receiving housing. 11 individuals met with Outreach Specialist and were given resources and assistance with housing applications, etc.

In addition to assisting with housing, we have also provided additional aid like transportation to medical/psychiatric appointments, bus passes, medication management, collaboration with St. Vincent DePaul, Catholic Charities, NCCAP, Social Services, Probation/Parole, and CW Solutions (FSET). Assistance was also provided with obtaining identification, setting individuals up with additional services through the ADRC as well as Community Treatment through NCHC. Case/Care Management is a service provided through both resources.

Collaboration with landlords and other non-profit agencies is on-going. Office hours at agencies throughout the city have proven beneficial in reaching the unhoused population.

#### **Challenges and Opportunities**

While we celebrate every time an unhoused individual achieves stable housing, the work does not and cannot end there. Generally, the unhoused population is vulnerable. Without someone providing ongoing support, management, intervention, accountability, and aid, the chances of remaining housed wane dramatically. In other words, our work can and will be undone in short order without systems to sustain the work. Thankfully, there are systems in place, but there are also gaps. Where gaps in case management exist, we are filling that void. We recognize, however, that our time and resources are limited in this regard. As a result, we are working to improve our understanding and relationship with existing systems while also exploring solutions that not only bridge the gap to housing, but to the essential supports that will make housing permanent.

#### **Success Story**

Multiple barriers exist for those who struggle with homelessness, who are trying to secure housing. Criminal history and eviction histories are primary barriers to finding a landlord who will give them an opportunity to rent from them. These, however, are not the only barriers the unhoused face when trying to secure housing. Many landlords are charging double, sometimes triple security deposits. Earlier this year, the Wausau Community Development Authority opened the section 8 waiting list, prioritizing "homelessness" when specific criteria were met.

On July 19<sup>th</sup>, I accepted an impact grant from the United Way. The amount awarded was \$5,250.00. This grant was awarded to help with security deposits for those unhoused, who were granted a section 8 voucher through our Wausau Community Development Authority. In the month of July, 3 individuals were housed because of this grant. Security deposits totaling \$2,595.00. An additional \$2,290.00 is earmarked for August. Since July 19<sup>th</sup> \$4,885.00 has been spent.
