



# Purpose of the meeting

The objective of today's meeting is to obtain your input on the identified needs and proposed improvements along approximately 1.5 miles of Stewart Avenue in the City of Wausau and Town of Stettin.

The City of Wausau is proposing this project in cooperation with Wisconsin DOT.





### Purpose and need for roadway improvements

The project need is defined by the improvements that must be made to the highway to address its deteriorated condition. The primary project purpose is improving the condition of the pavement on Stewart Avenue.

#### Pavement conditions

The existing pavement along Stewart Avenue was originally constructed prior in the 1930s and used to carry state highway traffic prior to construction of the WIS 29 freeway. The pavement has met the end of its service life with cracking, rutting, and deterioration throughout.

#### Pedestrian and bicvcle accommodations

48<sup>th</sup> Avenue is designated as a bicycle route on the Wausau MPO Bicycle and Pedestrian Plan and a multi-use trail is planned along the west side of 72<sup>nd</sup> Avenue by the City of Wausau in 2022.

There continues to be residential development north of Stewart Avenue in the Town of Stettin and City of Wausau generating bicycle and pedestrian users. There are no bicycle accommodations (shoulders are not paved) and no pedestrian facilities (no sidewalks) along Stewart Avenue. Bicyclists and pedestrians are using the existing unpaved shoulders.

#### Other needs

- City of Wausau municipal utilities (sewer and water) are outdated and undersized.
- The traffic signal equipment at the Stewart Avenue and 72nd Avenue intersection is outdated. The traffic signals were installed in 1994.

To address the project needs, a proposed solution must attempt to correct these key issues.

# **Recommended improvements**

- Reconstruction with 12-foot travel lanes/6-foot shoulders (36-foot roadway)
  - Paved shoulders would accommodate bicycles within the roadway
- Construction of curb and gutter and storm sewer
  - Some roadside ditches will be maintained for stormwater treatment between 72nd
     Avenue and 56th Avenue along the south side of the roadway
  - A stormwater pond will be constructed near 48th Avenue to treat stormwater
- Construction of a 10-foot multi-use trail along the north side of the roadway (see discussion on the following page)
- Extension of the existing drainage box culvert just east of 72nd Avenue.
- Reconstruction of sanitary sewer and water main.
  - The project will also include extension of the sanitary sewer and watermain facilities to improve system connectivity between 72nd Avenue and 48th Avenue.
- Replacement of traffic signals at 72nd Avenue with southbound left turn lane modifications and resurfacing of the asphaltic pavement within the intersection.

The recommended improvements are subject to approval of the final environmental document.

#### Pedestrian and bicycle accommodations

At the first public involvement meeting, we requested public and agency comments on two options for pedestrian accommodations throughout the project.

- 10-foot multi-use trail
- 5-foot sidewalk

Public and agency comments received supported the 10-foot multi-use trail option which is shown on the exhibits.

- The multi-use trail would provide accommodations for both pedestrians as well as bicyclists that do not want to use the roadway.
- The multi-use trail would provide for a multi-modal connection between the proposed 72<sup>nd</sup> Avenue multi-use trail (2022) and the bicycle route on 48<sup>th</sup> Avenue and sidewalks east of 48<sup>th</sup> Avenue along Stewart Avenue.

The City of Wausau proposes to maintain the trail including snow clearing.

On-street bicyclists would also be accommodated within the paved shoulder throughout the project. On-street bicycle accommodations are anticipated to be marked with an edge line and bike marking symbols.

#### Real estate

Additional right of way will be required for this project. This will include areas of permanent (fee) at select locations and temporary (temporary limited easement) land acquisitions throughout the project to accommodate blending of slopes, driveway match points, and stormwater.

Estimated right of way impacts are shown on the exhibits. The City of Wausau expects to begin real estate acquisition in early fall 2022.

Direct mailings and coordination will occur with impacted property owners. A landowner rights brochure is available for review.

# **Proposed traffic impacts**

The improvement project is currently scheduled for 2024.

- Stewart Avenue will be constructed under multiple stages to maintain local and business traffic
  - 72nd Avenue to 68th Avenue: Maintain two-way traffic with short term one-way conditions to complete the roadway, utility, and box culvert extension work
  - 68th Avenue to 56th Avenue: One-way conditions and full closures will be used to complete the roadway and utility work
  - 56th Avenue and 48th Avenue: Maintain one-way traffic at all times to complete the roadway, utility, and box culvert extension work
  - Short-term closures will occur during key utility work within the 72nd Avenue and 48th Avenue intersections
- Local and emergency access will be maintained to adjacent properties.
- Bicycles will be accommodated on existing travel lanes.
- The project is anticipated to take a full construction seasons (Spring to Fall).

### Other projects

The City of Wausau is proposing a multi-use trail along the west side of 72<sup>nd</sup> Avenue in 2022 (earliest construction).
