



RE: 2009 Training Annual Letter

The fire department provided a range of functional training in 2009 including competencies we haven't focused on in the past. In May, with the assistance of Marathon County Emergency Management, the fire department played a major role in a large scale, mass casualty exercise that included responses from multidisciplinary and multi-jurisdictional agencies. We provided the initial fire and emergency medical response to the incident and activated our Hazardous Materials Regional Response Team as well. The exercise provided realistic training that also allowed us to work within the Marathon County Emergency Response Plan with the activation of the Emergency Operations Center.

Throughout the year, Northcentral Technical College and Nicolet Technical College also provided training. Besides refreshers in confined space, hazardous materials, and defensive driving, they also provided training in radiation emergency response and emergency responder survival seminar in confrontational situations. We funded the coursework in hazardous materials and confined space by pursuing and obtaining grants through the State of Wisconsin Department of Emergency Management

With the end of 2009, while it is acknowledged that training is being conducted, an opportunity for improving our training program exists. The Department should pursue the appointment of a training manager who will be responsible for the design, development, and oversight of a training program that meets our organizational goals and objectives. This assignment should be high priority in 2010 and funded accordingly.

RE: 2009 Inspections Annual Letter

The year 2009, was a very good year for the Wausau Fire Department's Inspection Bureau. All commercial inspections were completed in a timely manner. Voluntary code compliance from our local business community was excellent. The City of Wausau Fire Department completed inspections on all known commercial underground and aboveground tanks within our jurisdiction per our contract with the State of Wisconsin Division of Commerce. We continue to protect our ground water, our citizens, and our fire fighters with annual inspections of these facilities.

Our School Fire Prevention Programs were reviewed and updated for this year. The big change for 2009 was to spend the month of October going to each school for the day, and making the classes more uniform in content. These programs build upon one another from one grade level to the succeeding grade level. This update required more line crew involvement and our programs were well received by the teachers and children.

Inspection compliance and fire prevention programs have proven to be valuable tools in preventing fire tragedies. These programs involve educating the public so that people will always be inspired to make fire safe decisions during the normal course of their lives. The programs teach the public to take specific and controlled action when a fire emergency occurs. Knowing the proper action to take during an emergency, reduces panic, and enhances the boundaries of fire safety for everyone. Our Goal is to make this year, a safer year than last, through the power of fire education and prevention.

2009 brought confirmation that new initiatives in the area of residential sprinkler installation will remain in our building and fire codes. This code movement will insure the installation of residential sprinkler systems in all new homes. Our work in this area is not yet complete. While adoption of residential fire sprinkler requirements in our major building and fire codes is a positive move towards the eradication of fire losses for both life and property, there is still much to accomplish to insure that these highly anticipated improvements to public safety become reality. The next step in implementing these vastly improved fire safety standards is getting them adopted....... un-amended at both the state and local level. Residential fire sprinklers will save property, help to reduce residential fire deaths, decrease the number of firefighter injuries and fatalities, and decrease the cost of our premiums for home fire insurance.

Finally, The Inspection Bureau would like to say "Thank You" to Mayor James Tipple and Fire Chief Gary Buchberger for their valuable and continued support. The support of our city leaders allows the Inspection Bureau to forge ahead in completing our inspection and fire prevention goals year after year. The Inspection Bureau hopes to continue and build upon this movement so that our great city will continue to prosper and grow.












