


Service to Our Citizens

Mission




Investigations Captain Gregory Hagenbucher

The Wausau Police Department Investigative Services Bureau, better known as the Detective Bureau, is dedicated to providing the highest quality of investigative, scientific, and information services for the purpose of maintaining law and order and protecting life and property. The duties and responsibilities of the personnel assigned to the Detective Bureau are numerous and quite diverse. Members of the Detective Bureau respond directly to crime scenes, and do their best to combat and reduce crime by conducting prompt, diligent, and professional investigations. Detectives maximize the use of all technological resources to solve crimes, track down and apprehend suspects, as well as to locate missing persons and recover and return stolen property to the rightful owner.




In 2013 and 2014, the Wausau Police Department's Investigative Services Bureau consisted of seven general detectives, three school resource officers (uniformed), two drug investigators who work with the Marathon County Special Investigative Unit, one civilian evidence custodian, two detective lieutenants, and one captain. A detective and detective supervisor are on-call 24/7.

In 2013 and 2014, the Wausau Police Department's Investigative Services Bureau saw an increase in the number of cases investigated over the past seven years. The total number of cases investigated by detectives increased from an average of 546 cases over the past seven years, to 602 cases in 2013, and 550 cases in 2014. For the most part the increases were due to cases involving arsons, robberies, counterfeit bills, forgeries, identity thefts, and burglary investigations. Arrests were made in about fifty percent of the cases investigated by the bureau.






In 2013 and 2014, the Investigative Services Bureau conducted a number of major investigations. Some of these cases included:

- Detectives continued to work leads on the Stephanie Low missing person case, which is now officially a homicide investigation. Ms. Low, a twenty-two year old female, was reported missing from her Westside Wausau apartment on October 10, 2010. Evidence found in her apartment lead officers to believe she had disappeared under suspicious circumstances. Detectives have conducted several hundred interviews, and followed up on over five hundred leads to date. On September 19, 2014, Ms. Low's decomposed body was located in a shallow grave on an isolated road in Forest County Wisconsin. The suspect is awaiting trial on 1st degree murder.
- Detectives investigated a homicide on June 19, 2012 where Kerby Kniess was found beaten to death with a baseball bat in a friend's garage on Wausau's west side. During the investigation it was learned that Mr. Kniess was beaten to death for a few dollars and some cigarettes. In November of 2014, a 20 year old suspect was sentenced to 35 years in prison and 15 years extended supervision, the 18 year old suspect was sentenced to 25 years in prison and 8½ year extended supervision.
- In April of 2013 Detectives investigated a homicide where Tong Hang was shot and killed in a Wausau basement. During the investigation detectives learned the suspect dismembered the body and transported the body parts to Milwaukee where they were located during the execution of a search warrant. The suspect was located and returned to Marathon County to face charges of 1st degree murder. The suspect pled guilty in 2014 and was sentenced to 40 years in prison and 20 years extended supervision.
- In June of 2013, detectives investigated a home invasion robbery where the occupants of the house were held at gunpoint while several males removed property and money from the residence. The suspects were later identified after becoming involved in two more robberies outside the City of Wausau. The 2 suspects are still awaiting trial for burglary while armed with a dangerous weapon, and armed robbery with the threat of force.
- In January of 2014, Detectives investigated a homicide where KC Elliott was shot to death in a tavern parking lot on Wausau's West side. During the investigation detectives learned that a fight had taken place between the victim and the suspect in the parking lot of the tavern, and a shot was fired. The victim died that same morning, and a short time later the suspect was taken into custody. The suspect is awaiting trial on 1st degree murder charges.
- During 2014 Detectives investigated numerous citywide burglaries. The suspects were later identified after being involved in multiple burglaries outside the City of Wausau. Three suspects are currently awaiting trial on more than ten burglary charges.





• In 2013 and 2014 Detectives investigated several heroin overdose deaths. The most significant heroin related incident being a vehicle accident on Thomas Street where Michael Dixon was killed, and his four year old son was in critical condition. Mr. Dixon had only been released from a drug rehab facility just one day prior to the accident. During this investigation Detectives identified a suspect that supplied the heroin to Mr. Dixon. In January of 2014, the suspect who supplied the heroin was sentenced to 8 years in prison and 5 years extended supervision.

In addition to these major crimes the Investigative Services Bureau has successfully closed many serious felony investigations with the arrest of people for the crimes of robbery, both armed and unarmed, endangering safety where the calls involved shots being fired, a few aggravated assaults, several arsons, several hundred sexual assaults (juvenile & adult), some embezzlement cases, and numerous burglaries and property crimes.

In 2013 and 2014, victims reported over two hundred crimes that involved:

- *Identity theft*
- Computer fraud
- Counterfeit checks
- Fraudulent checks
- Bank/loan fraud
- ATM card use in other states and foreign countries
- Lottery scams
- Re-mailing scams
- Internet fraud and theft
- Social security fraud
- *Cell phone threats*
- Pornography on cell phones

In 2013 and 2014 video surveillance has continued to play a roll in the identification of suspects involved in crimes. Numerous retail thefts, gas thefts and burglary suspects were identified after video surveillance of the suspects had been gathered and distributed to local law enforcement.


Investigators continue to attend specialized training in the areas of arson, homicide, sexual assault, financial crimes, computer crimes, and Internet fraud. In addition, cell phone technology training continues to be an emerging tool with multiple applications in law enforcement. Cellphone tracking can take several forms as a tool in investigations. Investigators can obtain everything from call and text-message records to subscriber information and location data. The information can illustrate everything from where a suspect's phone has traveled and whom he or she has been talking with before, during or after crimes are committed.


The Investigative Services Bureau is committed to providing the best service to the public, in an effort to create a significant impact on the quality of life in the City of Wausau.

In 2014, police officers in the United States have come under tremendous scrutiny. Officer-involved shootings in Ferguson, Missouri, New York City, and Cleveland, Ohio, have raised questions from some regarding policing in our country. Specifically, the rhetoric often heard is distrust of law enforcement. Simultaneously in 2014, deaths of law enforcement officers in the line of duty went up 24% from 2013. The number of officers killed violently by gunfire went up 56%. Included within these numbers are the 15 officers who died as a result of ambush-style attacks; triple the 2013 ambush-style murders of police officers.




Given the statistics of officer deaths along with public scrutiny, recruitment of police officers is becoming more challenging. Law enforcement is more polarizing today than ever before. To accomplish our mission, we must focus on recruiting high character individuals who are able to build bridges within the community.


What can law enforcement do to build that bridge with the community? This is the question command staff of police agencies across the country must answer in the coming years. For the Wausau Police Department, the answer to this question is building trust. Trust is accomplished in many ways and begins with our commitment to community oriented policing. 
Drug Enforcement




Violent Crime Index



Property Crime Index




Reportable Accident vs. Non-Reportable Accident—the difference between the two types of accidents is the estimated cost to repair damage sustained by a vehicle in the accident and whether a person is injured. An accident is considered reportable if the damage sustained by one vehicle is greater than \$1000, a person is injured, or if damage to government property occurs with a value over \$200.


Top Ten Crash Locations


Loss of a Retired Officer David Lewitzke June 23, 1931—September 8, 2014



Loss of a Crossing Guard Todd Seliskar November 2, 1967—September 16, 2014



In 2014, Mabel completed 85 searches.


Officer Shawn Fritsch & K9 Zanto










Emergency Police

The Emergency Police Unit of The Wausau Police Department was formed in 1951 to assist the department with traffic and crowd control. The unit is staffed by volunteers who volunteered over 3000 hours of service last year. The Unit assists with all of the parades, races, the Balloon Rally & Glow, the Wisconsin Valley Fair, The Festival of the Arts, Art in the Park, and other events as needed. The Unit is also ready for any Emergency, such as; storms, floods, or other happenings where the police may need additional staffing for scene security and crowd control. Wausau Emergency Police have training at various times during the year and work hard to be ready. The present director is Larry W. Jaeger and his executive officer is Major Frank Schuelke. There are three Squads and at present, 35 Officers. As in any volunteer organization, we are always looking for new recruits. A candidate must be at least 18 years of age, pass a background check and an interview to become a member. Our members range in age from 18 to 70 plus, both male and female. 



- Create better communication and working relationships between the citizens and Wausau Police Department.





September 2013, Wausau Police provided a safe and enjoyable atmosphere for the Pink Floyd Tribute concert crowd on the 400 Block.






September 2013, Out of the Darkness Walk. This fundraiser brings awareness and resources to help eliminate suicide.

October 2014, Wausau Police Department participates in the Texas Roadhouse Fundraiser for Special Olympics.








