Greetings, Wausau!

As I sit here writing this, it's the Spring Equinox and I'm reflecting on just how much we've gone through in the last year.

The top of my list is going from learning that all of Wausau's wells were contaminated with PFAS to providing water below the Department of Health Services health advisory in less than a year. Our ability to do that was due in no small part to the feedback you all provided to me, to your alders, and to our elected leaders at every level of government.

While we're still working on getting our permanent solution in place, we have been able to modify our operations to remove

PFAS using a special resin in our anionic exchange system at the new drinking water plant.

We were also so excited that Senator Tammy Baldwin secured \$1.6 million for Wausau for PFAS removal in the federal budget. We know that both the new drinking water treatment facility and this immediate, additional system is a heavy lift for our community. I'm very grateful for the support for finding this solution that we've received from you all – especially since we are now hearing from the federal Environmental Protection Agency that they are proposing PFAS levels at a much lower level, basically to near zero. The good news of our PFAS journey over the last year is that as a city, we are well ahead of many other utilities in our nation.

In other news, as our community and volunteer groups recover from the COVID-19 pandemic, we're looking at events and the opportunities for change that we have. One thing I've heard every Independence Day since I've been in office is about the annual 4th of July bash that usually takes place at Marathon Park. You want it back! Due to planned construction at Marathon Park this summer that will prevent having the event, we decided to work with the organizer to try something new for this year that will benefit our community, as well as our surrounding communities. We've proposed a huge fireworks display that will take place over Lake Wausau on the 4th of July – and we mean huge. We've already seen some communities approve going in on the costs for the display, along with our big sponsor Festival Foods, so we're feeling optimistic that we will all have an opportunity to celebrate our nation's 247th birthday together from our communities' various viewing spots along the lake.

Lastly, April is National Poetry Month! You'll want to check out Wausau's Facebook page every day for a new, original poem from Wausau's amazingly talented Poet Laureate Dawn Anderson.

Have a beautiful spring, Wausau!

Historic Preservation

The City of Wausau's Historic Preservation Commission

There has always been a strong appreciation for the history of Wausau, including stellar work of notable architects and the people of our history who have given us a landscape full of important houses and buildings. While these buildings have stood the test of time, there were some very significant buildings that met the wrecking ball: the Alexander Stewart House on 10th street, the Richardson Romanesque Court House on the 400 Block, First National Bank building 300 block of 3rd street, the old Franklin School on Bridge Street, and the old Lincoln School on Fifth Avenue.

However, it was the potential razing of the D.L. Plumer House at 714 - 5th Street that caused people in the community to make an effort to prevent it from being torn down. A year long effort to raise funds to save the house did not achieve the desired goal and the house was torn down in April of 1972.

This effort to prevent the razing of the Plumer house was in the context of a large national effort to set for a policy for historic preservation activities. This desire for a national policy on historic preservation was set in law with the passage of the National Historic Preservation Act of 1966. This legislation set the framework for preservation activities on a national, state, and local level. One of the key features of this law was the establishment of the National Register of Historic Places, which made it national policy to identify historically significant buildings, sites, and districts according to National Register criteria.

The Cyrus Yawkey House at 403 McIndoe Street, the Hiram Stewart House at 521 Grant Street, and the D.G. Jones house at 915 Grant Street were houses in Wausau that were soon placed on the National Register of Historic Places.



In 1975, the Wausau City Council established the City of Wausau Landmarks Commission creating Chapter 2.82 of the City of Wausau Municipal Code. This early version of the ordinance gave the Commission authority to landmark houses and buildings in the city. A much more controversial ordinance would come later in the mid 1990's.

The middle of the 1970's was the beginning of a concerted effort by preservationists in the city to make an effort to publicly "show off" historic architecture treasures in the city.

This was the beginning of an effort to present architecture walking tours and programs demonstrating the unique history of Wausau that is presented in its buildings. Don Aucutt and Maryanne Norton, key players in the early preservation movement,

wrote "City in the Pinery: A guide to Wausau's Historic Architecture." Also in 1984, Maryanne Norton was principal investigator and project historian for the "Intensive Historic Survey of Wausau". The project, the first of its kind in Wausau, was to identify significant architectural properties in Wausau. This project would guide the work of the City of Wausau Landmark Commission for years to come.

The preservation movement continued to be carried on through the City of Wausau Landmark Commission, later to be renamed the Historic Preservation Commission. A major revision to the City of Wausau's Ordinance happened in 1993 to make the ordinance in line with national historic preservation standards. The Commission would continue to landmark houses, buildings, and sites in the city and would create historic districts such as the Downtown Historic District, the Andrew Warren Historic District, the East Hill Residential Historic District, the Highland Park Historic District and the Eau Claire Addition Historic District. The local Andrew Warren Historic District, the East Hill Residential District, and the Highland Park Historic District mirror the boundaries of those districts on the National Register of Historic Places.

The Preservation Commission is governed by Chapter 2.82 of the Wausau Municipal Code which says in part that it is public policy to safeguard the city's historic and cultural heritage and embodied and reflected in such landmarks and historic districts.

A 1% late payment charge is added to the outstanding balance after the 20th of each month and is applicable to all customers. To avoid late payment charges, all bills must be received in the **office of the City Treasurer** by the due date printed on the front of the bill. Customers who pay at remote collection sites (grocery stores) are recommended to make payments prior to due dates to ensure timely receipt by the City Treasurer.



Spring Hydrant Flushing Begins May 8th


Avoid water use during the scheduled flush, especially for laundry purposes. It is particularly important to NOT use bleach in your laundry as it may stain your clothing. It is also suggested that you bypass water softeners during this time. Please also be aware that some homeowners may experience very low pressure during the flushing process.

Wausau Water Works anticipates the flushing to last about two weeks depending on emergencies or weather related delays. The progress may lead to flushing more than one zone per day. To work more efficiently the Wausau Water Works Department will completely flush the West Side before moving to the East side.

Property Maintenance Reminders

The City of Wausau has ordinances that are designed to protect the public's health and safety, and to preserve the appearance of neighborhoods. For the most part, City residents take great pride in maintaining their property in an aesthetically pleasing condition and comply with City ordinances.

When preparing for the Spring and Summer months, please keep in mind the following regulations:

EXTERIOR PROPERTY AREAS:

- Shall be maintained in a clean and sanitary condition, free from any accumulation of items, garbage, debris, yard waste.
- Yard waste cannot be placed on the Right-of-Way, including the alleys, boulevards, gutters and streets.
- Dog/animal excreta must be picked up in a timely manner, so as to minimize health hazards.
- Furniture, not intended for outdoor use, is not allowed on yards or open porches.

RECREATIONAL EQUIPMENT:

- Motor homes, camping and travel trailers, boats, boat trailers, snowmobiles, ATV's, utility trailers, etc. cannot be
 parked or stored in any required front yard or corner side yard, except for on a designated driveway which
 meets the City's hard-surfacing requirements.
- Equipment or trailers that are longer than 30' (measured from back bumper to tongue) must be parked within enclosed structures.





- Must be parked on established driveway/parking areas that are hard surfaced.
- Parking on the grass is not allowed.
- Vehicles that are unregistered/unlicensed, inoperable, abandoned, or in any state of major disassembly, disrepair, or undergoing overhaul are not allowed to be parked on residential properties.
- Motor vehicle repair is not allowed on residential properties.



SIGNS:

• Rummage sale, garage sale, real estate, advertising or other such signs cannot be placed on boulevards, other public right-of-way, or attached to public utility poles.

SOLAR INSTALLATIONS

Small solar energy systems are becoming a popular option for residents.

There are a few important things to know:



Every solar installation requires a permit. With the permit application you will need to submit a one-line diagram showing the wiring to the service from the panels which also includes specific equipment being used, along with cut sheets of equipment. We also require a directory and placement location for all required stickers required by the 2017 NEC.

The zoning code does have some regulations to consider under WMC 23.03.28. Some of the regulations are:

- The setbacks for a free-standing solar energy system would need to meet the requirements for accessory structure.
- Rooftop mount systems cannot exceed the peak of a sloped roof.
- The backside of any solar panel shall not face a public street.







Overnight Parking

ALL NIGHT PARKING: Parking is allowed on City streets (other than in designated areas in downtown—see below) on an alternate side basis **during the hours of 2:30 a.m. and 6:00 a.m.** It is not necessary to call the Police Department for permission. Vehicles must be parked on the even-numbered side of the street on even-numbered calendar days and on the odd side of the street on odd-numbered calendar days.





Keep in mind that the odd/even requirement pertains to the time period of 2:30 a.m. to 6:00 a.m. If you park your vehicle on the street in the evening intending that it will be parked overnight, make sure it is on the appropriate odd/even-numbered side of the street for the time period of 2:30 a.m. to 6:00 a.m.

DOWNTOWN AREA: Between the hours of 2:30 a.m. and 6:00 a.m., parking is not allowed in the area (including both sides of the streets) bounded on the north by McIndoe Street, on the west by First Street, on the south by Forest Street, and on the east by Sixth Street. Persons who live downtown (and occasional visitors) can park overnight in the parking ramp structures. However, your vehicle must be removed from the parking structure before 8:00 a.m., Monday through Friday, to avoid being ticketed.

SNOW EMERGENCY: Overnight parking will not be allowed during snow emergencies. Residents should keep in mind that even if a snow emergency has not been declared, vehicles which are parked overnight on City streets during snowfalls may hinder snow plowing operations.

The forfeiture for violating the overnight parking ordinance is \$25.00, and is \$100.00 during snow emergencies.

Selling a Vehicle in Wisconsin

Anyone who sells a motor vehicle from one individual to another individual (i.e. private sale), including transferring a junk vehicle by bill of sale, must submit notification of the sale to the WI Dept. of Motor Vehicles (WisDOT).

Within 30 days of a sale the seller needs to report the following information to WisDOT:

- Vehicle identification number (VIN) of the vehicle
- · Identity of the individual buyer
- Sale price
- · Date of sale

To submit seller notification online you need:

- To be an owner of the vehicle (must be an individual, not a business)
- Your Wisconsin driver license or identification card number (or full name)
- The last four digits of your social security number (or full SSN)
- · Your date-of-birth
- The vehicle identification number (VIN) for the vehicle

Once completed, you will have the option to print, email or save confirmation of your notification. Online submission:

What should I do with my license plates?

If you are selling your car, truck, van, or motorcycle, then please remove your license plates before allowing the new owner to drive away - the license plates are still registered under your name.

Newcomer's Corner

If you are new to Wausau, here are some things that are handy to know, before you learn the hard way...

- Wausau has a limit of 2 dogs and/ or 3 cats per household. A permit can be obtained if you have more. All cats and dogs must be licensed. Chickens can be kept with a permit.
- Building permits are required for most home improvements—call before you start a project!
- Garbage and recycling pick up is included in the property taxes. All residences are issued bins. Consult the schedule on our website to find out your pick up day.
- Backyard fires are allowed only by permit, which can be applied for at City Hall.
- Overnight parking follows an even/ odd date schedule all year long. See the police dept section for details.

- Sidewalks need to be cleared of snow and ice withing 24 hours. There are blue barrels for sand throughout the city that you can help yourself to for your slippery sidewalks. Snow is not to be shoveled into the street.
- During a major snowfall, a snow emergency may be declared, which means absolutely no parking on the street, even if you don't have driveway space.
- Water bills are sent quarterly, so it can take some time to get your first one (homeowners.)
- There is a curfew for those under the age of 16 between midnight and 6 am.

Emerald Ash Borer Advances in Wausau

Emerald Ash Borer (EAB), the invasive beetle killing ash trees, was first identified in City of Wausau in 2020. This winter, the beetle has been found in dozens of boulevard ash trees located throughout the city. This significant increase in findings marks the beginning of the wave of ash tree death for our community.

The Park, Recreation and Forestry Department follows the Wausau Emerald Ash Borer Management Plan. The Department will continue to remove or treat a portion of the ash trees to manage the infestation as opposed to allowing the beetle to manage us. Focused removal and treatment will be in the area west of the Wisconsin River for 2023.

For residents, it is imperative that every owner assesses their private trees and determines what to do with their ash trees. Every ash tree is susceptible and private trees are the responsibility of the property owner. If a private tree becomes infested or a nuisance to any public area, the property owner will be required to address per Wausau Municipal Code. Once EAB is established in a tree, the tree becomes brittle and hazardous in a short amount of time. The cost of removal typically increases once an ash tree is dead and the hazard from falling parts is very real. More information on EAB can be found on the Marathon County website:

Watering Newly Planted Boulevard Trees

Each year the Wausau/Marathon County Parks, Recreation and Forestry Department removes many trees for reasons like defects, storms or now Emerald Ash Borer. But did you know we plant hundreds of new boulevard trees too? Each tree is selected to best suit the site with an emphasis on species diversity.

At planting, each tree is mulched and given a generous drink of water. The Parks Department will return as time and staffing permit to water – which may only be a few times the rest of the summer and many times falls short of the trees' needs. Your help in watering the new tree(s) in your boulevard would greatly help! Each tree and site may slightly differ in needs, but below are general guidelines:

New Tree Watering

- Weeks 1-10 Water every 2-3 days about 2-3 gallons each time (water more frequently closer to planting).
- Weeks 11-freeze Water 1-2 times per week.
- Years 2-3 Water during dry periods.
- Trees require approximately 8-10 gallons per week for the size we plant.

Water with a good slow soaking, allowing the water to get deep into the soil. Water when there is not adequate natural rainfall. You may need to water more during drought conditions.

Some of the planted trees will have a tree watering bag installed. These bags are meant to be filled and the water trickles out over several hours to provide a slow deep soaking. If the boulevard tree at your residence has a bag, you may refill the bag at the intervals noted above.

Note that there is no permit necessary to water boulevards trees. The community would appreciate your diligence in helping our new trees grow!


