# Open bids and make recommendation for 2023 Wausau Municipal Parking Ramp Repairs – JC Penney Ramp

The following bids were received:

Wesolowski moved to award the contract to the low-qualified bidder, Western Construction Group, in the amount of \$153,315. Groat seconded and the motion passed.

### Open Request for Proposals for Professional Services – West Wausau Avenue, Stevens Drive to North 10<sup>th</sup> Avenue

Proposals were received from Ayres and EMCS. Wesolowski moved to review the proposals with a recommendation to be brought back to a future meeting. Groat seconded and the motion passed.

#### Make recommendation for Storm Sewer Materials (Quotations were opened March 28, 2023.)

Abbiehl stated 4 quotes were received, which were from County Materials, Ferguson, Brock White/White Cap and Neenah Foundry. He provided a breakdown listing the low quote for each item. He noted the quotes were similar to last year with prices up a bit. He is recommending the purchase of concrete items from County Materials, castings mostly from Ferguson with some from Brock White/White Cap and Neenah, and rings from Ferguson. Wesolowski questioned why some items did not have an amount listed. Abbiehl explained no bids were received for those items and some things are not used anymore.

Groat moved to accept the low bids as presented. Wesolowski seconded and the motion passed.

### Discussion and possible action on the purchase of asphalt from two vendors

Abbiehl stated last year they mostly used RC Pavers as they are closer, there is less travel time, and less labor. However, last year they were hit and miss, and they could not get asphalt on demand so more asphalt was purchased from American Asphalt. This year they estimate purchasing 70% from RC Pavers with 30% from American Asphalt.

Wesolowski asked if the recommendation is to purchase the majority of asphalt from RC Pavers because their costs are lower. Abbiehl confirmed.

Groat moved to approve as recommended. Wesolowski seconded and the motion passed.

### Business Campus Trail $-72^{nd}$ Avenue, Stewart Avenue to International Drive: Janke General Contractors, Inc., Pay Estimate #1

This pay estimate was reviewed by Niksich and the project inspector. Approval is recommended. Wesolowski moved to approve Pay Estimate #1 in the amount of \$890,935.55. Groat seconded and the motion passed.
