Minutes of previous meetings. (03/20/23)

Motion by Diny, second by Larson to approve the minutes of the previous meeting. Motion carried 5-0.

Consider approval or denial of various license applications

Lisa Rasmussen stated there were denial recommendations for Operator's Licenses for Kristopherlee Firkus and Phillip Komosa. Neither individual was present to appeal. There was also a denial recommendation for a Public Transport Driver License for Donald Alsteen.

Donald Alsteen, 209732 County Rd Y, Hatley addressed the committee stating his record was accurate, but the offenses all happened in his drinking days. He indicated he quit drinking approximately six years ago. He explained the reason for all the drinking was because his family owned a lot of bars which he cleaned as was given free drinks. He admitted to doing many stupid things when he was younger between 17 and 19 years old. He stated the charge of 4th Degree Sexual Assault was from a 4-year teenage relationship with a girl whose parents had consented to and then changed their mind. He stated he wanted to get his record expunged but chose jail time rather than probation which did not him allow to get record expunged. He stated he was trying to get his life together for his wife and kids. Driving cab would be a good job for him because he could take his autistic son along. He pointed out he has no repeat offenses.

Lou Larson questioned why he was being denied in the first place because the charges on the record were at least 11 years old and were misdemeanors. Deputy Chief Barnes explained they look at the established criteria and battery is an exempt offense.

Chad Henke suggested he bring any written evidence of rehabilitation or letters of recommendation to the committee's next meeting.

Motion by Diny second by Larson to approve or deny licenses as recommended by staff, with the exception of Donald Alsteen to be held for the next meeting. Motion carried 5-0.

NOTE: Subsequent to this meeting Phillip Komosa's employer called to say he had not received the letter regarding the denial recommendation in time to attend the meeting. He was removed from the license list and put on the next PH&S meeting to allow for an appeal.

Discussion and possible action on Amending the title and provisions of Chapter 5.63 Obstructions within the Central Business District Public Rights-of-Way, Section 12.44.040 Exceptions, Section 5.64.035 Alcohol licensing and serving of alcohol beverages, and Section 1.01.025 Issuance of citations; creating Chapter 5.65 Sidewalk Cafés.

Lisa Rasmussen explained a number of years ago a conduit was created specifically for full-service restaurants in the Central Business District to allow for sidewalk cafes for outdoor seating with or without alcohol service, depending on their liquor licensing. During the pandemic expansion of those seating areas were permitted. She indicated Liz Brodek brought a request from some businesses outside of the Central Business District that would also like to have sidewalk cafes. One of those businesses making a request is Kreger Bakery.

This ordinance would allow for either a Sidewalk Café License for full-service restaurants or an Obstruction Permit for other business types to be available city-wide.

Motion by Henke, second by Larson to approve. Motion carried 5-0.

<u>Discussion and possible action on Designating the Month of May 2023 as "No Mow May" and suspending enforcement of W.M.C. §6.48.010 Mowing Required and §6.48.040 Penalty from May 1, 2023 through May 31, 2023</u>

Rasmussen noted this is the third season that "No Mow May" has been allowed.

Motion by Larson, second by Henke to approve "No Mow May" for 2023. Motion carried 5-0.

Operations Report from Fire Department March 2023

Deputy Chief Jeremy Kopp commented on a recent water rescue and training of newly hired firefighters. *Report placed on file*.

Community Outreach Update

Lisa Rasmussen noted due to high water warnings and flooding a flood mitigation gate was deployed and the individuals had to be relocated out from under the bridge and shelter capacity expanded to accommodate them.

Deputy Chief Barnes explained the Police Department, DPW, and the Parks Department were notified by Wisconsin Public Service that the forecasting was going to require the gate. The encampments located under the Scott Street Bridge as well as on The Mandarin side, and all the encampments on Barker-Stewart Island were removed. All the property that was on city-owned property is being stored for 30 days and notices were posted everywhere on how to retrieve the personal property. He stated it is the intention of the Police Department not to allow those encampments to return to those areas which they don't feel are appropriate for them to be living.

Craig Vincent, Bridge Street Mission, addressed the committee explaining their ministry operates a daytime place to be for the unhoused community from 10:00 AM to 3:00 PM every day at 115 W Bridge Street. It is highlighted be a very nice sit-down meal. At 1140 W Bridge Street is the Sober Living Center which is a programmed homeless shelter with a goal of taking people from the point of need to where they can function again in society. The three phases are 1) Stabilization, which is getting them off the street;2) Transformation, where the hard work it done to help them function again in society; and 3) Re-entry, where although they are still living with us, they are working again and making connections in the community. It is a 24/7 programmed shelter and they are not out in the community but are supervised in productive activities. He indicated they would eventually like to offer this to women.

16.04.037 Rent abatement.

- (a) Statement of intent. The Common Council of the City of Wausau hereby finds that in order to insure the proper repair and maintenance of residential buildings within the City of Wausau, to prevent the deterioration and neglect of such structures for the protection of the health and safety of the people of Wausau and to further enforce compliance with The BOCA Basic Housing-Property Maintenance Code of the City of Wausau and the Wisconsin Administrative Code, Chapter SPS 321 and 362, it is necessary, in the case of uncorrected rent-impairing violations, that tenants residing in the City of Wausau be authorized to abate an appropriate portion of their rental payments under the provisions of this section.
- (b) Notice. A list of addresses of rental properties with uncorrected rent-impairing violations shall be published each week on the official City website within ten days of the reinspection which reveals noncompliance. Such notice shall indicate that the tenants may be eligible for rent abatement and shall state that any such tenant must request authorization to abate rent within 30 days of publication of the notice of eligibility by the Inspection and Zoning Division of the Department of Engineering. A copy of the notice shall also be sent by first class mail, addressed to "Occupant" at each rental unit with uncorrected rent-impairing violations, on or before the date of publication of the notice. Together with the copy of the notice there shall be mailed a cover letter including, but not limited to, the following information: Notice of Eligibility to Apply for Rent Abatement The owner of your residential dwelling has not followed an order from the City of Wausau Inspection and Zoning Division to correct housing code violations. Because the owner has not complied, you may be able to get a portion of your rent back pursuant to Wausau Municipal Code 16.04.037.

(c) Definitions.

- (1) Affected applicant in rent abatement categories where the percentage of rent abatement is expressed as a certain percentage or a certain dollar amount "per affected applicant", abatement only applies to those dwelling units/lodging rooms affected by the violation and only if a tenant therein has applied for rent abatement.
- (2) Affected dwelling unit or lodging room means a dwelling unit or lodging room in which a rent impairing violation exists or a dwelling unit or lodging room in a residential building where a common area violation exists.
- (3) Applicant encompasses the total number of eligible tenants residing in a dwelling unit or lodging room where an eligible tenant has applied for rent abatement and not an individual eligible tenant within the unit or room.
- (4) Common area violation means a condition constituting a rent impairing violation which exists in any part of a residential building or lot not contained within a dwelling unit or lodging room.
- (5) Eligible tenant(s) means any current tenant(s) of a landlord of residential premises where the landlord has had a residential rental license denied, revoked, suspended or non-renewed, or fails to comply with an order of the Inspection and Zoning Division of the Department of Engineering to correct a rent impairing violation by the original due date in the orders unless that date is found unreasonable by the Public Health and Safety Committee, provided that the tenant has lived in an affected dwelling unit for some portion of the time period from the date of the initial inspection by the building inspector to the close of the 30-day period during which a request for abatement hearing may be filed. Any tenant, to be an eligible tenant, must have a valid rental contract with the landlord and must have the landlord's authorization to occupy the property.
- (6) Per fixture means per affected appliance regardless of how many separate rent impairing violations may affect that appliance.
- (7) Only facility means the only appliance of its kind in the dwelling unit or lodging room.

- (8) *Provider agency* means any governmental agency or private social services agency which by contract provides rental assistance on behalf of low-income tenants where such assistance payments are paid directly to the landlord.
- (9) Rent impairing violation a rent impairing violation within the meaning of this section shall designate a condition in a dwelling unit, lodging room or other area of a residential building or lot which constitutes or, if not properly corrected, will constitute a fire hazard or a threat to the health or safety of occupants thereof. Such conditions include but are not limited to those which involve deficiencies in security, heating, electriCity and/or plumbing.
- (10) Successor tenant(s) means any individual(s) who become(s) a tenant in a dwelling unit or lodging room where a prior tenant was authorized or is in the process of being authorized to abate rent pursuant to this chapter and where, at the time of tenancy of the successor tenant commences, there exists an uncorrected rent impairing violation which was determined or is in the process of being determined by a hearing examiner to be abatable. Anyone who succeeds a successor tenant is also a successor tenant, provided that at the time her/his tenancy commences there exists an uncorrected rent impairing violation for which abatement was authorized. (Ord. 61-5602 §1, 2013, File No. 12-0206)

(d) Authorization of rent abatement.

- Eligibility. Notwithstanding any other provision of law or any agreement, whether oral or written, tenants and provider agencies shall be eligible to abate a portion of the total rental payments, in accordance with this section and pursuant to the order of the Public Health and Safety Committee or by written agreement of the parties, if the landlord of the residential premises fails to comply with an order of the Inspection and Zoning Division of the Department of Engineering to correct by the original due date, unless such due date is found to be unreasonable upon appeal to the Public Health and Safety Committee, a violation which is "rent impairing" as that term is defined in this chapter. Any such order of the Inspection and Zoning Division shall specifically state that uncorrected violations may be eligible for abatement in addition to any other penalties provided by law. A tenant's eligibility to abate rent shall apply only to the eligible tenant(s) or successor tenant(s) upon whose rented premises the uncorrected rent impairing violation exists or to any eligible tenant(s) or successor tenant(s) in a building with an uncorrected rent impairing violation in a common area. A provider agency's ability to abate rent shall apply only to provider agencies which pay or have paid a portion of an eligible tenant's rent while an uncorrected rent-impairing violation exists on the premises or common area of the eligible tenant's building. Where an award is made and rent has been paid by both a tenant and a provider agency, the tenant's portion of the award shall be up to but not greater than the amount of rent the tenant has paid. Where the award amount is less than or equal to the amount of rent the tenant paid, the tenant shall receive all of the award. No rent may be abated pursuant to this ordinance until abatement is awarded by the Public Health and Safety Committee or authorized by written agreement of the parties.
- (2) Other remedies. The right of a tenant to abate a portion of the rent as established by this section shall not preclude or affect in any way the tenant's right to abate under Wis. Stats. ch. 704; nor shall it preclude or affect in any way the tenant's or landlord's right to any of the remedies provided by the laws of the State of Wisconsin and the Wausau Municipal Code pertaining to the relationship of landlord and tenant.
- (3) Designation of rent impairing violations. The Common Council shall adopt a list of violations of the provisions of chapter 16 of the Wausau Municipal Code and the Wis. Admin. Code ch. SPS 321 and 362, to be classified as "rent impairing" as above defined. Said list shall contain a brief description of the condition constituting the violation, the section of the ordinances violated and the percentage range of any possible rent abatement. The Public Health and Safety Committee may at any time recommend a change in the number of violations, their descriptions or the percentage of possible rent abatement for a particular violation but no such change shall be made except in the manner set forth above.

(4) Schedule of rent impairing violations. A tenant authorized to abate rent shall do so in accordance with the schedule which follows at the end of this section, with the precise amount to be set by the Public Health and Safety Committee after notice and hearing pursuant to subsection (5). The maximum total abatement authorized pursuant to this ordinance shall not exceed 95 percent of the periodic rental payment, except where the premises have been vacated pursuant to an order of the Inspection and Zoning Division of the Department of Engineering or pursuant to any other tenant right to remove from residential rental premises secured under Wisconsin law.

(5) Procedure.

- (A) Application for authorization for rent abatement. An eligible tenant who may be entitled to abate a portion of his/her rental payment under this ordinance shall have 30 days from mailing of the notice of possible eligibility by the Inspection and Zoning Division of the Department of Engineering to file a request for a hearing on authorization for rent abatement. The request shall be in writing on a form approved by the Public Health and Safety Committee, shall state with specificity the name and address of the landlord and the alleged rent impairing violation(s) and shall be filed with the City Clerk. The application shall be accompanied by a fee as provided in section 3.40.010(a) made payable to the City Treasurer, which fee shall be recovered from the landlord if abatement is ordered. The time and place for the hearing shall be the next regularly scheduled meeting of the Public Health and Safety Committee, but not prior to the end of the 30-day filing period. Notice of the hearing including a statement of the time, place and nature of the hearing shall be mailed to the landlord and tenant(s) at least ten days prior to the hearing.
- (B) Role of the Public Health and Safety Committee.
 - (i) The Public Health and Safety Committee shall have the authority to conduct hearings on requests for authorization for rent abatement and to determine the exact amount of rent, if any, which may be abated pursuant to this ordinance.
 - (ii) The Public Health and Safety Committee shall have the authority to administer oaths and to issue subpoenas pursuant to WI SS 885.01 at the request of the parties and shall be responsible for the fair, orderly and impartial conduct of the rent abatement hearing and the preservation of the exhibits and the record therein.
- Conduct of hearing. The Public Health and Safety Committee shall conduct the hearing on the request for authorization for rent abatement, shall administer oaths to all witnesses and may issue subpoenas upon request of the parties. So far as practicable the rules of evidence in WI SS 227.45 shall be followed. The landlord and the tenant may be represented by counsel or other representative, may call and examine witnesses and cross-examine witnesses of the other party. All proceedings and testimony shall be recorded on tape. If a review is sought of the committee's decision, a copy of the tape recordings shall be supplied to anyone requesting the same at the requester's expense. If either party requests a stenographic recording and transcription, the Committee shall make the necessary arrangements, but the expense shall be borne by the requesting party. In the hearing, the tenant(s) shall have the burden of proving to a reasonable certainty by the greater weight of the credible evidence, i.e. by the preponderance of the evidence, that the landlord failed to correct (a) rent impairing violation(s) by the due date in an order of the Inspection and Zoning Division. It is the landlord's burden to show by the preponderance of the evidence that any rent impairing violations were negligently or willfully caused by the tenant or the tenant's guests or that the tenant's refusal to allow entry prevented the landlord from making the corrections in a timely manner. Thereafter, the tenant has the burden to show that any such refusal was reasonable under the circumstances. Either party may present additional evidence on the nature, extent and seriousness of violations, the length of time conditions existed and the extent to which the tenant was deprived of the full use of the rented premises, to assist in determining the percent of abatement which should be allowed.

(D) Decision.

- (i) If, on the evidence at the hearing, the Public Health and Safety Committee finds that the landlord failed to comply with an order of the Inspection and Zoning Division to correct by the original due date a "rent impairing" violation as that term is defined in subsection (c), the Committee shall order that the rent be abated retroactive to the date of the initial inspection in order to effectuate the purpose of this ordinance and to provide fair and equitable compensation to the tenant(s) for the diminished value of the rented premises due to the landlord's continued violation of the City of Wausau's building/housing codes. Any such abatement shall be established in accordance with the Schedule of Rent Impairing Violations referenced in subsection (d)(4). In setting the exact percentage of abatement the Committee shall consider the nature, extent and seriousness of the particular condition(s), the total number of rent impairing violations at issue, the length of time the condition(s) existed and the extent to which the condition(s) deprived the tenant(s) of full use of the rented premises. If the Committee finds that the landlord's failure to comply with the order of the Inspection and Zoning Division by the due date was caused by factors wholly outside the landlord's control and if the Committee further finds that the landlord has taken affirmative steps to minimize the impact of the uncorrected rent-impairing condition(s) on the tenant(s), any sums reasonably expended by the landlord in that regard should be considered in setting the percentage of abatement and may operate to reduce the final abatement percentage below the minimum percentage listed for the item(s) in the Schedule of Rent Impairing Violations in subsection (d)(4). The Committee shall not authorize rent abatement for any condition(s) found to be caused either negligently or willfully by the tenant or his/her guests, nor shall abatement be ordered for any period of time after the tenant has unreasonably refused entry to the landlord for the purpose of correcting the condition(s) giving rise to the violation(s).
- (ii) If, after the hearing, the Committee finds that the landlord did not fail to comply with an order of the Inspection and Zoning Division to correct a rent impairing violation by the due date or that the rent impairing violations were caused by the tenant or the tenant's guests or that the tenant unreasonably refused entry for the purpose of correcting a rent impairing violation, the Committee shall enter an order denying the request for authorization to abate rent for any items negligently or willfully caused by the tenant or guests of the tenant or for any items which remained uncorrected due to the tenant's unreasonable refusal to allow entry for repair purposes.
- (iii) The decision and order of the Committee shall contain written findings and shall be mailed to the parties within ten days of completion of the hearing or as soon thereafter as possible. The failure to issue and mail a decision within ten days shall neither deprive the Committee of jurisdiction to render a final decision in the matter nor affect the validity thereof.
- (iv) The holder of the landlord's interest in the premises at the time of the decision and order of the Committee is issued and the holder or holders of the landlord's interest during the period of time that the right to continuing abatement remains in effect are bound by the order and by the applicable provisions of this chapter relating to rent abatement.
- (6) Petition for reconsideration. Within ten days after service by first-class mail of the decision of the Committee, either party may file with the City Clerk, a written petition for reconsideration specifying in detail the grounds for the relief sought. The Committee may on their own motion reconsider the decision or order a hearing on reconsideration without the filing of a written petition.
 - (A) Reconsideration will be granted only on the basis of a material error of fact or law or an error in the calculation of an award amount, or

- (B) Copies of the petition shall be served by first class mail by the petitioner on all parties, who may file replies within seven days after service by mail of the petition.
- (C) Within 21 days of the filing of the petition, the Committee shall enter an order denying reconsideration or an order granting reconsideration disposing of the petition without a hearing or shall order a rehearing, which shall be held within 20 days. The failure to issue a decision within the above time period shall not deprive the Committee of jurisdiction to render a decision on reconsideration or affect the validity thereof. If no order is entered within 21 days of the filing of the petition, the petition shall be deemed denied.
- (D) Upon rehearing, if any, proceedings shall conform to those in section (d)(5) et seq. relating to an original hearing.
- (E) The filing of a petition for rehearing shall not suspend or delay the effective date of the original decision and order, and the order shall take effect on the date fixed by the Committee and shall continue in effect unless the petition is granted or until the order is superseded, modified, or set aside as provided by law.
- (7) Request for modification. If, subsequent to a decision by the Committee ordering rent abatement, substantial further deterioration or substantial improvement occurs in any rent impairing conditions which were the subject of the original order, the applicant, landlord or any successor tenant may request modification of the rent abatement amount. Only one such request for modification may be made by each eligible individual, which request shall follow the procedures in section (d)(5) et seq. relating to the original application.
- (8) Enforcement. Whenever, in the judgment of the Public Health and Safety Committee, the judicial enforcement of the ordinance is necessary, the Committee shall in writing request the City Attorney to enforce the ordinance in the name of the City of Wausau.
- (9) Appeal. All orders of the Public Health and Safety Committee shall be final administrative determinations and shall be subject to review in court as by law may be provided. Any party to the proceeding may seek review thereof within 30 days of service by first-class mail of the final determination of the Committee. In addition, written notice of any request for judicial review shall be given by the party seeking review to all parties who appeared at the proceeding before the Committee, with said notice to be sent by first class mail to each party's last known address.

The institution of the proceeding for judicial review shall not stay the decision and order of the Committee; however the reviewing court may order a stay upon such terms as it deems proper.

- (e) Successor tenant.
 - (1) A successor tenant is entitled to abate rent pursuant to the order of the Public Health and Safety Committee issued in accordance with this chapter, provided that at the time the tenancy commences there exists an uncorrected rent impairing violation which was determined or is in the process of being determined by the Committee to be abatable.
 - (2) In order to be deemed a successor tenant under this ordinance, an otherwise eligible individual must advise the landlord in writing, with a copy to the Inspection and Zoning Division of her or his intent to exercise his or her rights as a successor tenant, no later than 15 days after receipt of written notification by the landlord which conforms to the requirements of section 16.04.037(g). If said written notification is given at or prior to the time the rental agreement is entered into, the successor tenant's notice of intent must be given no later than 15 days after the commencement of the successor tenancy.
 - (3) Failure to provide the landlord with a timely written notice of intent to become a successor tenant forfeits a tenant's right to proceed to abate rent as a successor tenant under this chapter, except

where the landlord has failed to provide the written notification of the tenant's right to abate rent pursuant to subsection (2) above. In cases where the landlord fails to provide written notice as required, an otherwise eligible tenant may assert the rights of a successor tenant at any time during the tenancy or in any action relating to or arising out of the tenancy.

(f) Duration of abatement.

- (1) Authorization to abate a portion of the rent pursuant to subsection (d) for failure of a landlord to correct a rent impairing violation ceases upon certification by the Inspection and Zoning Division of the Department of Engineering that said violation has been satisfactorily corrected. Where more than one rent impairing violation has been authorized for rent abatement and partial correction has been certified, authorization to abate continues for the uncorrected rent impairing violations, until such time as their satisfactory correction has been verified.
- (2) If abatement is authorized, the landlord must promptly repay any rent previously paid by the tenant, provider agency or successor tenant and apportioned to rent impairing violations from the date of the original inspection by the Inspection and Zoning Division at which said violations were discovered.
- (3) If the landlord fails to promptly reimburse the tenant, provider agency or successor tenant as required in subsection (2) above, the tenant, provider agency or successor tenant may enforce the order requiring reimbursement as follows:
 - (A) The tenant, provider agency or successor tenant may deduct the amount previously paid and subsequently determined to be apportioned to rent impairing violations from future rental payments.
 - (B) If the total of future rental payments payable for the balance of the tenancy is less than the reimbursement required in subsection (2) above or if the tenant or successor tenant no longer resides at the premises in question, the tenant, provider agency or successor tenant shall recover from the landlord the amount not reimbursed in accordance with the order of the Committee plus costs of collection including reasonable attorney fees. Nothing in this ordinance shall prohibit a tenant from collecting double damages if not being reimbursed for abated rent meets the definition of a security deposit violation under ATCP 134.02 (11) and ATCP 134.06.
- (4) The failure of a landlord to promptly reimburse the tenant, provider agency or successor tenant as required in subdivision (2) above and the failure of either a landlord, tenant or a provider agency after a decision by the reviewing court on judicial review, to pay monies wrongfully not reimbursed or return monies wrongfully abated shall be deemed a violation of this ordinance and shall be punishable as provided in this section.
- (5) Rent abatement awarded in a decision and order of the Public Health and Safety Committee shall accrue during the period when either a tenant or a successor tenant is entitled to the exclusive possession and occupancy of an affected dwelling unit. Under no circumstances shall there be recovery by both a tenant and a successor tenant for the same period of time.
- (g) Rent abatement and code violations disclosure. The landlord or any person authorized to enter into a rental agreement shall exhibit to the prospective tenant, prior to the time a rental agreement is entered into, the following:
 - (1) A copy of any official notice of outstanding violation(s) of chapter 16 of the Wausau Municipal Code or Wis. Admin. Code ch. SPS 321 and 326 of which the said landlord or person has actual notice and which affects the subject rental building regardless of the location of the violation(s) or defect(s) therein;
 - (2) A copy of any Public Health and Safety Committee decision and order which affects the subject rental unit or any common areas of the subject rental building.

(3) The failure by a landlord to comply with the provisions of this subsection regarding written notice of a successor tenant's right to abate rent shall not be subject to the penalties set forth as provided in this section.

In addition, prior to the time a rental agreement is entered into, the landlord shall advise the prospective tenant in writing of a successor tenant's right to abate rent pursuant to the order aforementioned until authorization to abate ceases as provided in subsection (f) above. In cases where the rent abatement request is pending at the time the rental agreement is entered into, the landlord shall provide the successor tenant written notification of a successor tenant's rights when the case has been decided and shall exhibit a copy of the decision and order to the successor tenant upon receipt thereof.

Finally, at the time occupancy commences the landlord shall exhibit to the tenant (formerly, prospective tenant) a copy of all additional official notices referred to in subdivision (a) above and a copy of all decisions and orders referred to in subdivision (b) above, if any have been issued since the signing of the rental agreement. Similarly, at the time of occupancy the landlord shall provide the required written notice of a successor tenant's rights with respect to all such additional official notices and decisions.

The written notice of successor tenant's rights shall specifically state in underlined or otherwise emphasized print the following: "If you wish to become a successor tenant and to abate rent in accordance with section 16.04.037 of the Wausau Municipal Code you must provide your landlord and the Inspection and Zoning Division with written notice of that intent within 15 days of receiving written notification from your landlord of your right as a successor tenant to abate rent. Failure to provide your landlord with timely written notice forfeits your right to be a "successor tenant" and to abate rent as a successor tenant under section 16.04.037 of the Wausau Municipal Code."

- (h) Prosecution. It is the intent of this section that any use of abatement will not prohibit the Inspection and Zoning Division of the Department of Engineering from prosecuting violations of the code relating to said property.
- (i) Penalty.
 - (1) Any person violating any of the provisions of this section shall upon conviction be subject to a forfeiture of not less than \$150.00 nor more than \$900.00, unless a different penalty is specifically provided, with each separate day of violation to be considered a separate offense.
 - (2) Any person who shall fail or neglect to comply with any lawful order of the Public Health and Safety Committee issued pursuant to the provisions of this section shall be deemed guilty of a violation of this section, and every day or fraction thereof on which such person shall fail or neglect to comply with such order, shall be deemed a separate offense.
- (j) Severability. In the event that any section of this ordinance shall be declared or judged by a court of competent jurisdiction to be invalid or unconstitutional, such adjudication shall in no manner affect the other sections of this ordinance, which shall be in full force and effect as if the said section or said sections were not originally a part thereof.
- (k) Effective date of ordinance. This ordinance shall be effective and apply to all orders written by the Inspection and Zoning Division of the Department of Engineering on or after April 1, 2012. Any amendments to this ordinance relating to rent abatement shall be effective and apply to all orders written by the Inspection and Zoning Division of the Department of Engineering 90 days after the publication of this ordinance as amended.

Re: Municipal Code Updates WMC Title 15 and 17

The City of Wausau recently became fully delegated by Department of Safety and Professional Services (DSPS) to perform plan reviews for all non-hospital commercial buildings. We have contracted with E-Plan Exam to perform these larger plan reviews for the city.

When Wausau applied for the full commercial building delegation, E-Plan reviewed our building and fire codes that are adopted in WMC Titles 15 and 17. There were several needed updates to these chapters. DSPS conditionally approved our delegation based on the city updating our building and fire codes.

Some of the highlighted proposed changes:

- 1. Removed definitions so that we can rely on state standard definitions in both building and fire codes.
- 2. Added language on delegated municipality and what documents are needed for plan review and submittal.
- 3. Removed the fire district ordinance. The Fire District does not meet state requirements for a uniform building code (Act 270). The modern building codes have built in protections for fire sprinkler and fire alarm requirements.
- 4. Removed language and cleaned up conflicts with the zoning code. Screening and paving parking lots and sign code standards are in Title 23. Moved garage size regulations from Title 15 to Title 23.
- 5. Removed sign code language. This is adopted in the building code and is not needed.
- 6. Removed adoption of NFPA 101 in Title 17. This was above the state standard and is prohibited by Act 270.

Changes in Title 23 will require a public hearing next month at plan commission. Changes in Title 15 and 17 can be approved by PH&S and city council.

- Section 5. That Section 15.12.010 State code adopted, is hereby amended to read as follows:

15.12.010 State code adopted.

The following provisions of the Wisconsin Administrative Code, so far as applicable, are adopted by reference and incorporated in this chapter as though fully set forth:

WAC SPS 360-366 (Building and Heating, Ventilating and Air Conditioning Code);

WAC SPS 310 (Flammable and Combustible Liquids Code); and

WAC SPS 320-325 (Uniform Dwelling Code).

WAC SPS 327 (Camping Units).

Section 6. That Chapter 15.20 Building Permits, is hereby amended to read as follows:

. . . .

15.20.0320 Plans and specifications.

No building permit shall be issued for any new building or structure until plans and specifications are approved by the Building Inspector. Such plans shall consist of a neat and legible approximate sketch showing the builder's intention and the exact outside dimensions of the building and indicating the type and nature of construction. Specifications shall clearly set forth the manner of construction and the type and nature of the materials to be used. Plans shall be in sufficient detail to show the exact nature of the work to be done and shall include a plot plan showing the location of the building with respect to property lines and they shall remain on file in the files of the Building Inspector.

15.20.025 Delegated Appointed Agent Municipality.

- (a) The municipality has adopted the Appointed Agent Municipality Status as described in SPS 361.60 and SPS 382 of the Wisconsin Administrative Code.
 - (1) Responsibilities. The City shall assume the following responsibilities for the Department of Safety and Professional Services (Department):

- (A) Provide inspection of commercial buildings with certified commercial building inspectors.
- (B) Provide plan examination of commercial buildings with certified commercial building inspectors.
- (b) Plan Examination. Drawings, specifications and calculations for all the types of buildings and structures, except state-owned buildings and structures and other structures exempted in SPS 361.03(3), to be constructed within the limits of the municipality shall be submitted, if the plans are for any of the following:
 - (1) A new building or structure.
 - (2) An addition to a building, structure, or building system such as fire alarm, sprinkler, plumbing, or HVAC system.
 - (3) An alteration of a building space, element, or structure. Including alteration of an existing fire alarm system, fire sprinkler system, plumbing system, HVAC system or replacement of equipment or fixtures within those systems.
 - (4) A certified or delegated municipality may waive its jurisdiction for the plan review of a specific project or types of projects, or components thereof, in which case plans and specifications shall be submitted to the Department for review and approval.
 - (5) The department may waive its jurisdiction for the plan review of a specific project, where agreed to by a certified municipality, in which case plans and specifications shall be submitted to the certified municipality for review and approval.
- Plan Submission Procedures. All commercial buildings, structures and alterations, including new buildings and additions require plan submission. Submission can be submitted via electronic or digital media. If plans are approved electronically, two (2) sets of hard copies bearing the approval stamp of the designer is still required to be submitted prior to permit issuance. Alternatively, plan submission is as follows:
 - (1) Building permit application
 - (2) Application for review State of Wisconsin forms as applicable based on trade submitted or Municipal Equivalent.
 - (A) Fees per municipal fee schedule
 - (B) Fees apply to all commercial projects
 - (3) 1 set of plans with 3 Project cover sheets
 - (A) Signed and sealed per SPS 361.31
 - (B) (1) set of specifications
 - (C) Component and system plans
 - (D) Calculations showing code compliance

Note: Nothing in this code or chs. SPS 361 to 366 is intended to prohibit the submission and acceptance of plans and construction documents in an electronic or digital media. - (b) Qualifications of inspectors. Only qualified personnel shall make inspections or perform testing required by the current edition of State of Wisconsin Fire Prevention Code and the adopted provisions of technical codes. Qualified personnel shall include, but not limited to:
 - (1) Personnel who are factory-trained and certified for the type and brand of device, equipment, alarm, system, or feature being inspected or tested;
 - (2) Personnel who are certified by a nationally recognized certification organization approved by the City;

- (31) Personnel who are registered, licensed, or certified by the State of Wisconsin or the City of Wausau to perform the required inspections and testing; or
- (4) Personnel of the Fire Department.
- <u>Section 13</u>. That Chapter 17.12 Definitions is hereby repealed.
- Section 14. That Section 17.48.010 Inspection of exits, is hereby amended to read as follows:

17.48.010 Inspection of exits.

Not more than 90 minutes prior to the scheduled commencement of any noncontinuous activity, event, performance, show, meeting, function, or other occasion for which persons will gather at a Class A or B commercial place of assembly (as defined in the 2012 Edition of the Life Safety Code - NFPA No. 1011), the owner (or designee pursuant to written authority, instructions or procedures), shall inspect every required exit, ways of approach thereto, and way of departure therefrom. If such inspection reveals that any required means of egress is obstructed, inaccessible, locked, fastened, or otherwise unsuited for immediate use, the scheduled program shall not begin, nor shall admittance to the place of assembly be permitted, until necessary corrective action has been completed.

Section 15. That Section 23.03.28(2) Accessory land uses and structures, is hereby amended to read as follows:

23.03.28 Accessory land uses and structures.

. . . .

(2) Detached accessory building: Detached buildings accessory to a residential use including but not limited to buildings used to shelter parked passenger vehicles (including garages) and workshops, greenhouses, boathouses, and pool houses.

Regulations:

- (a) One total detached accessory building shall be permitted by right. Attached garages shall not count toward this total.
 - 1. A conditional use permit (section 23.10.32) shall be required for any additional detached accessory building beyond one.
- (b) A combined total of 1,200 square feet of gross floor area of all detached accessory building on the property is permitted by right. For lots larger than one acre, the maximum permitted combined total of gross floor area of all detached accessory building on the property shall be increased by one square foot for every 100 square feet of lot area over one acre. In no instance shall the detached accessory building area exceed the ground floor area of the

principal building used for residence. An individual detached accessory building shall not exceed 900 square feet of gross floor area. If additional square footage is necessary, then approval from the Building Advisory Board must be obtained in accordance with WMC title 15. Total of all garage areas, attached and/or detached for dwellings containing less than 3,200 square feet of total floor area shall not exceed 900 square feet.

- Total of all garage areas, attached and/or detached for dwellings containing 3,200 square feet or more of total floor area shall not exceed 1,200 square feet.
- (d) Total area of detached garages shall not exceed 900 square feet.
- (ee) See article II for detached accessory building heights.
- (df) Detached accessory buildings are permitted in the rear yard and side yards only. (Detached garages are not permitted in waterfront yards.)

The construction of said garages must be architecturally compatible with that of the principal building. Private garages in excess of the above mentioned square footage may be constructed with prior approval of the Building Advisory Board.

WAUSAU PD OPERATIONS REPORT



1st Quarter, 2023

Chief's Message

As mentioned in our last quarterly report, we have hired many new officers. At the time of this writing, we have 5 officers in the police recruit school and 5 more that are in training. This is a strain on our field training staff, first line supervisors and patrol bureau as they work to both train officers and cover patrol shortages. By the end of the summer our new officers should be trained and our staffing level will be back to "normal."

In February, assessors from the Wisconsin Law Enforcement Accreditation Group (WILEAG) were on site for our accreditation assessment. This happens every three years and is an arduous process. The assessors were impressed with the detail found in our policy manual and accreditation proofs. In addition, they were impressed by the volume of services and programs offered by our department. On May 8, we will receive our official recognition of WILEAG Accreditation for the next three year period.

Officer Jena Zinkowich received the Women's Community Assisting Survivors of Sexual Assault Award for her work and investigation of a violent sexual assault case. Officer Josiah Kaetterhenry received the Hometown Heroes award in the Madison legislature for saving two lives last year. Officer Aaron Karlen was recognized at a state banquet in Milwaukee as a Top 10 Drug Recognition Expert for his work as a DRE in 2022. We also promoted Officer Garrett Carr to Patrol Lieutenant and Officer Ben Thumann to Detective.

Installation of our Flock automated license plate reading cameras have been mostly installed and are functioning well. We have had a number of successes with these cameras during investigations. Examples include the identification and apprehension of a male perpetrator who exposed himself at the drive through of a local coffee shop, apprehension of a person committing numerous gas thefts, location of a vehicle involved in a Milwaukee-area crime, and others.

Counting Rules

Counts on this page are based on the month of the incident or arrest, rather than the month the incident was submitted. If the incident date is unknown, the report date is used. Counts are subject to change as data are updated.

Offense counts are calculated based on the number of offenses for each victim (per incident) for Crimes Against Persons and the number of unique offense types (per incident) for Crimes Against Property and Crimes Against Society. For burglary and motor vehicle theft, offense counts are based on the number of premises entered and the number of vehicles stolen, respectively.

Victim counts are calculated based on the number of victims connected to each unique offense type in an incident. For Crimes Against Persons, the number of victims will be equal to the number of offenses. Victims will be counted more than once if they are connected to multiple offenses.

Arrest counts are calculated based on the number of arrestees listed on a Group A or Group B incident. Each arrestee is counted only once per incident.

Arrests are categorized based on the specific Group A or Group B arrest code submitted by the agency, rather than the incident offense code. Since agencies only submit the most serious arrest charge for each arrestee on an incident, arrest counts are not indicative of the number of charges.

Incidents are cleared in one of two ways: by arrest or by exceptional means. Clearance counts are based on the number of offenses cleared in a given month regardless of when the offense occurred, and can therefore be greater than the number of offenses in a given month. In incident-based reporting, the first arrest on an incident, or an exceptional clearance, will clear all offenses associated with the incident.





Summary

2021 had the highest number of police responses to drug overdoses in WPD history. That year, we responded to 40 overdoses, 12 of which were fatal.

In 2022, there was a 12% decrease in total overdoses (at 35). That decrease was primarily owed to a drop in fatalities. 2022 saw 9 fatalities (down 25% from the previous year).

Overdoses continue to trend downward in 2023. Through March, there's been 7 reported overdoses, 3 of which were fatal.

"CFS": Calls For Service (Officer initiated activities and calls received from Dispatch).

"Mental Health" and "Welfare Check" are the two most common types of CFS (coded by Dispatch based on the initial information reported) that involve individuals in crisis.

"Community" origin of 51.15 / 51.45: Law enforcement is called to a location in the community (*residence*, *business*, *public location*) in response to an individual in crisis (or incapacitated). De-escalation, safety planning, and/or diversion is not viable or is unsuccessful, resulting in 51.15 or 51.45 detention.

"Facility" origin of 51.15: While under care or custody of the Jail, NCHC, or medical facility; an inmate or patient is suicidal or otherwise assessed on-site by a Crisis Professional, and deemed in need of 51.15. Law Enforcement is then called upon to confirm and complete the 51.15 (as required by WI Stats.) Lacks opportunity for diversion.

"51.15": "Emergency Detention" under WI Statute 51.15. Law enforcement may take into custody an individual who is:

- (1) Mentally ill, drug dependent or developmentally disabled, and;
- (2) A substantial probability of physical harm to him/herself or others is evident by recent acts or omissions, attempts or threats.

"**51.45**": "Alcohol or Drug Detention" under WI Statute 51.45. "A person who appears to be 'incapacitated by alcohol or another drug' shall be placed under protective custody by a law enforcement officer."





Fire Chief Report by Chief Robert Barteck

April was an interesting month. Hot topics for the month were Rural EMS, Wisconsin Regional Type II Hazardous Materials Response Team, and a visit from Senator Tammy Baldwin.

In March of 2023, the Wisconsin Office of Rural Health released a report highlighting a growing problem in the Wisconsin Rural EMS System (link below). Rural EMS providers struggle to find enough responders to serve their community's needs. Because Wausau Fire provides EMS coverage to five rural jurisdictions and contracts for ALS Intercepts with another eight rural EMS agencies, we feel the effects of this growing problem. As rural EMS agencies struggle to staff ambulances, they are forced to turn to neighboring jurisdictions to ask for help in response. Because Wausau Fire is the largest EMS agency in the region, we are keeping a close eye on this problem and are seeking new ways to support partner EMS agencies.

On April 11, we were honored to host Senator Tammy Baldwin for a tour and discussions with our staff about our operations. This was our first chance since being awarded the SAFER Grant to thank her in person for supporting our application and award in 2022. While here, Senator Baldwin participated in an EMS training scenario set up by EMS Division Chief Thompson in an ambulance. The on-duty crew walked the Senator through the station and described their jobs. The Senator strongly understands the current problems facing fire/EMS agencies across Wisconsin. Much of our conversation focused on the status of rural EMS in our region and how Wausau Fire is essential for response in the region.

The Marathon County Health Department hosted a Public Health and EMS Budget Roundtable discussion with Wisconsin DHS Secretary Kirsten Johnson. During the meeting, we discussed current budget-related issues with the DHS Secretary. Primarily the need for additional funding help in the form of EMS Flex grants and shared revenue reform with funds earmarked for public safety. I relayed the problems currently facing the Wausau Fire EMS system and our ideas for how the estate can help us.

Wisconsin State Fire Chief's president, Chief Mike Stanley (from Oshkosh Fire Department), appointed me to the HazMat Advisory Committee with four other chiefs from around Wisconsin. Our purpose is to support and continue to grow the capabilities of the regionalized system. I was fortunate to serve in this role in the past and hope to protect our system from state budget cuts and continue to expand the system's capabilities.

The Common Council approved renewing the contract for our Regional Hazardous Materials Response Team with the State of Wisconsin for July 2023 to June 2025. The state biannual budget is still being hashed out, and currently, the Regional HazMat System is not included. The Wisconsin State Fire Chiefs are advocating for a \$1 million annual budget to fund the system. This would include an increase over what we currently are receiving. We have received \$84,000 annually for the last ten years to provide a Regional Type II Hazardous Materials Response Team and hope to see an increase in the next budget to cover growing costs.

The Wisconsin Joint Finance Committee held four public listening sessions. On April 12th I joined four other Fire Chiefs in Wisconsin Dells to testify to the committee about the need for funding in several key areas. I spent my 2 minutes advocating for the proposed alternative Share Revenue plan that would earmark funds specifically for public safety. I also spoke about the need for funding the Wisconsin Regional Hazardous Materials Response System. The other Chiefs discussed the need for EMS funding and PFAS Foam disposal funding.

On April 13th I traveled to the La Crosse Fire Department to serve on an interview panel for Battalion Chief promotional process. The new La Crosse Fire Chief, Jeff Schott will have a difficult job picking between the six candidates that applied for the promotion. Wisconsin Fire Chiefs frequently help each other with these processes, and Chief Schott has traveled twice to Wausau to help us with our past processes. It was a great learning experience to see how La Crosse FD conducts its selection process.

EMS Division by EMS Division Chief Jared Thompson

CAAS Accreditation

We have not had any further correspondence from CAAS since sending our updated application. Additional information shall be conveyed when received.



EMS Training

Over April, the EMS Division focused on tracheostomy emergencies and the use of our ventilators. The City of Wausau is unique because the Health Care Center has a full-fledged ventilator unit. The patients that reside there often have tracheostomies and are usually ventilator dependant. This can sometimes pose challenges to our crews because they have to manage whatever medical emergency that is presented to them and manage the patient's ventilator. All ambulances carry their own ventilators, which require extensive training. Our crews focused on tracheostomy emergencies and how to manage our ventilators in those crisis situations.







Pain Emergencies

In April, our paramedics had 15 patients who were administered a narcotic for pain management. Pain is a prevalent request for an ambulance that we receive every day. Our paramedics have the ability to manage a patient's pain by use of Fentanyl or Hydromorphone. Some of the complaints ranged from shoulder to back pain to hip pain. Studies have shown that early, effective pain management can speed up the recovery from an injury. Our paramedics also exercise discretion not to over-medicate their patients or administer these narcotics to drug seekers. At the end of every month, as the EMS Division Chief, I must reconcile these medications and maintain an accurate inventory that the DEA requires.

Cardiac Care Benchmarks

The EMS Division is proud to share that we met two main cardiac benchmarks tracked monthly. I want to share the "12 Lead ECG report when a patient presents with acute coronary syndrome (ACS)" benchmark. For April, we surpassed our goal of obtaining a 12 Lead ECG within 10 minutes of patient contact 90% of the time with 99%. This means that every patient that presented with ACS received this procedure within ten minutes. We can then transmit that ECG to the emergency department for further interpretation.


Fire Training Division by Training Division Chief David Briggs

April Scheduled Training:

A brief breakdown of our scheduled activities follows:

- Ground Ladders
- Airboat Operations
- Technical Rescue Boat Operations with Rescue
- Hose Testing (Moved to May due to weather)

Ground Ladders

There are certain fundamental skills every firefighter must master. One of those is the ability to deploy ground ladders and roof ladders when the scene dictates. Deployment was performed at the three stations around the city on different ground conditions, roof heights, flat and peaked roofs, and varying weather conditions. This month, the crews not only trained on the deployment of the ladders, but they chose to perform a complete maintenance on them. Maintenance included cleaning, painting the balance points, and painting the tips for improved visibility. Our ladders are manufactured in Oshkosh, Wisconsin and tested annually by another Wisconsin company.

Airboat Operations & Technical Rescue – Boat Operations with Rescue

These drills are different, but very linked. Every boat operator in the department is required to perform a "driving" course annually and perform multiple maneuvers to display proficiency. Along with their operational skills, our members must perform victim rescues from the watercraft and either pull victims into the boat without entering the water or enter the water to facilitate the rescue. These skills are very specific and easily performed incorrectly. Training throughout the year as different water and ice conditions are present helps to ensure we are well-prepared for any type of water rescue.

Fire Department Instructor's Conference (FDIC)



Training Division Chief Briggs and Deputy Chief Kopp both attended the world's largest fire instructor conference, FDIC. TDC Briggs attended two pre-conference sessions as part of the FDIC "HOT" sessions. These pre-conference days include <u>H</u>ands <u>On Training</u> in any number of different topics.

On Monday, April 24th, TDC Briggs attended "Operating in The Flow-Path by Flowing and Going." This session rotated participants through live fire scenarios on the fire floor, above the fire, flowing water while advancing hoselines, and search and rescue techniques with victim removal. Of this 11.5 hour day, numerous insights were gained from instructors from LA County Fire and Cobb County Georgia Fire Department. A major aspect of this conference is the ability to learn perspectives and techniques that differ in perspective than what is taught regionally. On TDC Briggs' first day back to work following FDIC, he already began to show the crews improved tactics while performing drills.

On Tuesday, April 25th, TDC Briggs attended "Elevator Emergency Management." This program was taught by some of the nation's leading experts on elevator emergencies that are trained elevator technicians and skilled firefighters, some with 40 years on FDNY Rescue 1. The session lead by Dragon Rescue Management and their cadre began with elevator familiarization, lock-out/tag-out procedures, unlatching elevator hoist way doors, accessing the elevator car, assisting victims out, removal of victims from the elevator's ceiling hatch, securing elevators from lowering or raising, and manually lowering hydraulic elevators. While we have very good elevator policies and procedures here in Wausau, lessons were learned, and we will make some adjustments to improve our response capabilities.

On Wednesday, DC Kopp joined TDC Briggs at FDIC and attended multiple breakout sessions on leadership, strategies and tactics, training program management, and other concepts. Some time on Thursday and Friday was spent split between classes and one of the largest trade shows in the industry. While trade shows may not sound educational, they provide us with personal interaction with our vendors and on new equipment and technology to keep our members safe while performing their duty to serve the community.

Fire Prevention Division by Fire Marshal Brian Stahl

Inspections: Within the City of Wausau for the month of April, we performed 157 total inspections. We had 31 properties that had Fire Code Violations with 45.2% being Fire Extinguisher Annual Maintenance. These properties will require follow up inspections to confirm compliance. We conducted 4 consultation inspections for the month. Two for Fire Suppression systems, one new construction Site review, and one Fire Alarm system.

Investigations: The Prevention Division investigated one fire the month of April. The property involved was a two-story, single-family residence. This fire was classified as accidental.

Public Outreach: Throughout April we performed outreach seven different times. Three of these were witnessing Fire drills at schools. These drills require time management, accountability, and organizational benchmarks for our staff to advise on. We performed one Fire Safety presentation for a senior and adult living facility. We also performed three site reviews for Fire Code and City ordinance clarifications.

Education: Lt. Shahn Kariger left for the National Fire Academy on April 2nd for the Fire Investigation: Forensic Interviewing and Evidence class. This class was completed on April 7th. Shahn has passed this class in further advancement for his Certified Fire Investigator (CFI) certification. The Prevention Division inspectors completed all the EMS certification continuing education that is needed to continue our licensures. This education is obtained through the Tech college or through our department instructors.

Significant Calls:

Wausau Fire responded to five structure fires in in the month of April, two of which were mutual aid calls outside the city. Another fire call with a freight truck on fire on Highway 29 and one swift water rescue call. The victim from the water rescue call was already out of the water upon our arrival thanks to Wausau P.D.

Recruitment and Retention:

Three of our Paramedic students are finishing up Paramedic class and will be testing during the first week of May and starting a five-person academy on May 8th. Stay tuned for a huge swear in ceremony in June! C crew and I were able to attend another job fair in April at the UW-Stevens Point Wausau campus where high school students were bussed in from outside areas as far as Tomahawk and Gresham to learn more about jobs in our area.

Fleet:

Med 2 is back in service, unfortunately Med 1 and Med 4 went out of service in late April. This means we are down to three meds only while having to rely more on neighboring departments to help us when we have all three meds out on calls. We are looking forward to the delivery of the new ambulance in October! The new command truck (Battalion 1) went in service and is doing very well replacing Car 2.

Buildings and Grounds:

We are still anticipating the remodel of Station 3 apparatus bay this year. New gear lockers were ordered for Station 1 to handle the new hires gear. I am brainstorming and gathering ideas for personal vehicle parking next year at Station 1 and Station 3. When we move into our new deployment and staffing plan in January of 2024, we will not have enough parking for our employees at these two stations with the already limited parking we have.



They were able to arrange for a currently licensed bartender to come to the bar. When preparing to issue a citation for No Licensed Bartender, the officers learned that the owner/agent was present the entire time. As such, no violation occurred, and no citation was issued. It would have been more convenient for the owner/agent to have made their presence known earlier in the incident.

(1) Event #23048244, 04/15/2023 at 2:02 AM: SERVICE MISCELLANEOUS: Officers observed a female pinned up against a wall while a male was pushing against her. When the officer pulled up, someone yelled "Cops!" and everyone started to disappear. The officers stood by to make sure there were no other problems. The female involved hid from the officers and refused to have contact. Ten minutes later, the two were seen together again, pushing on each other. Officers contacted them, even though the two walked away from the officers and absolutely refused to cooperate. Each of them got a ride from the bar through a responsible person.



Unhoused Data

The following graph shows the number of unduplicated¹ persons housed by each organization in the previous month.



Unhoused Data Summary

In April, data suggests there were approximately 202 unhoused individuals in Wausau. The data this month does not reflect Salvation Army's numbers because they were not reported. As indicated in the footnote, 202 is more than the true number of unhoused. As of today, organizations do not cross-reference names when coming up with their unduplicated count. This means an unhoused individual may be part of more than one organization's count, thereby inflating the true number of unhoused. An example is provided in the footnote.

¹ The numbers reflected do not eliminate duplicates across organizations. For example, a person who stays at Catholic Charities and the Salvation Army in the same month will count as 1 person for each organization.

In the graph above, 83 percent of the unhoused sought or received shelter in the month of April, 17 percent of the unhoused were living outside, or in places not meant for human habitation.


The Women's Community data includes crime victims who sought shelter because their home was unsafe. This number reflects both single females (11) and their children (15).

Bridge Street Mission includes individuals who have received shelter after release from jail/prison, drug rehab, or homelessness. In previous reports, the number reported to this committee only reflected a small number of individuals who sought shelter in preparation for being transitioned into the "apartments" on the main level of the building. The number reflected should include all individuals who are housed at Bridge Street Mission, because without this amazing program in our community, 38 (per this month's census) individuals would likely be unhoused in our community.

The Marathon County Jail includes individuals who identify as "homeless" at the time of booking.

Daily Census

We are working hard to collaborate with partner organizations to get a handle on shelter capacity in Wausau. It's important to know if we're meeting or exceeding capacity. The Salvation Army has a capacity of 28. The Warming Center has increased their capacity to 30 (as of 4/28/23) but can expand to 40 when temperatures fall below 15 degrees or above 90 degrees. In sum, there is shelter space for 58 individuals on a given night between the 2 organizations.



Daily Census Summary

On average, capacity was at 85 percent for the month of April. The Salvation Army reached maximum capacity 5 nights for the month of April, for a total of 16 percent capacity in April. Catholic Charities was at or over their capacity a total of 28 days in the month of April, for a total of 93 percent capacity in April.

Continued collaboration exists to ensure that the unhoused population have access to services during the upcoming summer months.

We continue to work with our partner organizations to learn how many people are turned away each day. In addition to capacity, individuals are turned away for a variety of other reasons. The "turn-away" statistics for the month of April are as follows: Catholic Charities = 67 and Salvation Army = No data reported.

Outreach Update

In April, outreach resulted in 1 individual receiving housing. Year to date, 23 individuals have been assisted into stable housing. and we are excited to report that 100% of those who have received housing remain housed at this time.

In addition to assisting with housing, we have also provided additional aid like transportation to medical/psychiatric appointments, medication management, collaboration with St. Vincent DePaul, Catholic Charities, and NCCAP. Assistance was also provided with obtaining identification, setting individuals up with additional services through the ADRC as well as Community Treatment through NCHC. Case Management is a service provided through both resources.

Collaboration with landlords and other non-profit agencies is on-going. Office hours at the Marathon County Library twice per week, the Open Door once per week, and one day per week at the Community Partners Campus have proven beneficial in reaching the unhoused population.

Challenges and Opportunities

While we celebrate every time an unhoused individual achieves stable housing, the work does not and cannot end there. Generally, the unhoused population is vulnerable. Without someone providing ongoing support, management, intervention, accountability, and aid, the chances of remaining housed wane dramatically. In other words, our work can and will be undone in short order without systems to sustain the work. Thankfully, there are systems in place, but there are also gaps. Where gaps in case management exist, we are filling that void. We recognize, however, that our time and resources are limited in this regard. As a result, we are working to improve our understanding and relationship with existing systems while also exploring solutions that not only bridge the gap to housing, but to the essential supports that will make housing permanent.

Stories of Success

30 year old male, originally from Iowa. Came to Wisconsin Rapids and got into some legal trouble. Ended up in Wausau for Shelter and stayed until his recent court date. I made contact with his mother and she indicated that he would be able to come back home to live with her. I contacted the Wood County DA's office to ensure that this client could leave WI. After verification, bus tickets were purchased and this young man was reunited with his family back in Iowa.
