In compliance with Wis. Stat. s. 19.84, notice of this meeting was duly posted and sent to the *Wausau Daily Herald* in the proper manner.

Noting the presence of a quorum, at approximately 5:17 p.m., Chairperson Rasmussen called the meeting to order.

Minutes of previous meetings. (06/19/2023)

Motion by Henke, second by Diny to approve the minutes of the previous meeting. Motion carried 4-0.

Consider approval or denial of various license applications

Lisa Rasmussen stated there were denial recommendations for applicants for Operator/Bartender Licenses: Donna Brown, and Morgan Sykes; and for Public Transport Driver Licenses: Damien Martinez. It was noted that none of the applicants were present to appeal.

Rasmussen stated there was a Class A Liquor Application: For Frenchie Sake, LLC, owner Jennifer Phillipson doing business as Grand Ave Artifactory, 2312 Grand Avenue. She will be selling wine baskets.

Rasmussen stated the Liquor License Review Subcommittee met immediately before this meeting, with the applicants, to consider applications for the only available Class B Beer & Liquor License: 100 Proof Management LLC, owner John Troemel with a business name yet to be determined on the premise address of 102 Jefferson Street; and Onora Hotels, LLC, owners Juan Casarrubias and Lesli Iverson doing business as Venado Craft Beer on the premise address of 209 Grant Street. Rasmussen stated the unanimous vote of the Liquor License Review Subcommittee to move forward on the recommendation of Onora Hotels, LLC, owners Juan Casarrubias and Lesli, to receive the standard available Class B Beer & Liquor License. The receiving applicant was chosen due to having an open and operating business that was ready to use the Class B License upon receiving it.

Motion by Larson, second by Diny to approve or deny licenses as recommended by staff. Motion carried 4-0.

Consider recommendation(s) from Liquor License Review Subcommittee for applications for Class B Beer & Liquor

Rasmussen ruled that this item was considered with the previous motion to approve or deny licenses as recommended by staff. Onora Hotels, LLC is acknowledged as the recipient of the Class B Beer & Liquor License.

Operations Report from Fire Department June 2023

Deputy Chief Kopp announced the closing of the month's employment opportunity window, and they did not select any of the applicants as they are looking for people with the right fit for the department. They are working with the City Human Resources Department to engage in other employment opportunity windows in the future.

Kopp stated the department is continuing to work with CAAS Accreditation. They have resolved compliance issues to seek the accreditation and are awaiting documentation. They hope to be on the agenda for CAAS Accreditation in August.

Report placed on file.

Tavern Activities Report - June 1, 2023 through 30, 2023

Chief Bliven discussed compliance checks that were carried out on 7 establishments, with 5 of the establishments failing the checks as they sold alcohol to an underage person. Citations were issued and demerit points on the establishments were also issued. Bliven stated that since the COVID-19 pandemic, compliance checks were not

regularly carried out and the numerous violations outlined in the report could be due to establishments not being used to the checks. The remainder of the report was discussed.

Larson acknowledged Jalapeno's Bar and Restaurant for having demerit points dropped off their record. Rasmussen clarified that the points dropped were due to enough time passing since their last compliance violation and that they hope to see continued improvement.

Report placed on file.

Community Outreach Update

Tracy Rieger, Outreach Coordinator, disseminated the report for which the information included did not include data from the Salvation Army due to staffing issues at that organization. Rieger reported 209 unhoused individuals in the community. She pointed out that the number of nights that both shelters reached capacity was very low. Catholic Charities reported achieving full capacity in 6 nights of the last month which indicates unhoused individuals are seeking shelter at the Salvation Army or other resources, they reported that 13% of individuals were turned away due to late arrivals and 87% were turned away due to capacity. Salvation Army has more turn aways due to more data-points examined when intaking individuals. Rieger reported housing 2 individuals in the last month for a total of 31 individuals that have successfully been helped to find housing. Three individuals she had previously housed became unhoused again. Rieger stated she will continue to work with those individuals to seek housing for them.

Rieger updated the committee that she is working on the Housing Task Force with Jeff Handcock, Craig Vincent, and Donna Ambrose to develop a severe weather plan for the winter and the summer as well. Rieger hopes to have the plan ready for the task force to consider in August.

Larson asked for more information on the closing of the Open Door organization. Chief Bliven confirmed their closing on the previous Friday due to the resignation of an Executive Director. Bliven answered that the Open Door Board of Directors are working to fulfill that role again. Discussion followed.

Subject: Request for Waiver of 3.06.010(a)

Date: August 18, 2023

The Public Transport Driver license for Adrian McMahan is recommended for approval but will be placed on hold for a delinquent water bill in the amount of \$924.64. Mr. McMahan is asking for a waiver of 3.06.010(a) due to financial hardship per 3.06.010(c) – see attachment with highlights.

3.06.010 - Payment of taxes, claims, forfeitures, judgments prior to issuance of license or permit.

- (a) The payment of all personal property taxes, special assessments, and room taxes imposed pursuant to Title 3 of this Code, all forfeitures or judgments resulting from conviction for violation of any ordinance codified in the Wausau Municipal Code, except moving traffic violations, and all other judgments due and owing from any applicant to the City at the time of the application for any license or permit provided for in these ordinances, and any of the same relating to the property or business previously licensed if the new license is granted consequent or conditionally upon the sale or transfer of the business or stock in trade or furnishings or equipment of the premises or of the ownership or control of a corporation is a condition precedent to the granting of such license or permit. If the personal property tax bill has not been issued, the Treasurer shall require advance payment based on the previous year's mill rate multiplied by the premises' or property's or business' current year's valuation. No license or permit application shall be granted until the Clerk or his/her designee has investigated the applicant so that all required payments have been made.
- (b) Alleged errors in amounts claimed to be due the City may be appealed to a committee comprised of the Assessor, the Finance Director, and City Attorney or their designees. The committee shall have no authority to review any matter for which a review or appeal procedure has been provided by statute or other ordinance. Within five days of being informed of an amount claimed due, the person seeking review shall pay the amount claimed and file a written notice of appeal with the Clerk stating the bases for the appeal and specifying the alleged error. Upon payment, the applicant may file the application for the license or permit if otherwise qualified. As soon as practicable, the committee shall hold a hearing at which the person shall present evidence to substantiate the claimed error, call witnesses in his/her own behalf, may cross-examine witnesses and may be represented by legal counsel. After holding the hearing, the committee shall by majority vote make findings of fact and conclusions and shall correct any established errors. Any amount improperly required paid shall be refunded promptly, together with interest at the rate of 12 percent per annum from the date the amount was paid to the City to the date of refund.
- (c) In cases of extraordinary financial hardship, the Public Health and Safety Committee shall be authorized to waive the provisions of subsection (a). The City Clerk shall be required to document the hardship and present a report of the circumstances requesting the waiving of these provisions to members of the Public Health and Safety Committee.



Re: Adopting Wis. Stat. 941.2965 to the Municipal Code



Synopsis

The Police Department is seeking approval to adopt Wis. Stat. 941.2965, Restrictions on Use of Facsimile Firearms, to 9.04.010 of the Wausau Municipal Code.

Background

The State of Wisconsin restricts the use of facsimile firearms.

A "facsimile firearm" means any replica, toy, starter pistol or other object that bears a reasonable resemblance to or that reasonably can be perceived to be an actual firearm. "Facsimile firearm" does not include an actual firearm.

According to Wis. Stat. 941.2965, "No person may carry or display a facsimile firearm in a manner that could reasonably be expected to alarm, intimidate, threaten or terrify another person."

Whoever violates Wis. Stat. 941.2965 is subject to a Class C forfeiture.

Because the associated penalty does not rise to a misdemeanor offense, the City of Wausau must incorporate the statute in Municipal Code to enable enforcement through citation. Wis. Stat. 941.2965 is currently not in the list of adopted state statutes under 9.04.010 (WMC).

In a recent case, officers were dispatched to locate a stolen vehicle from the City of Marshfield. The suspect was reportedly in possession of a black handgun and informed others that he would shoot police if they attempted to stop him. The vehicle and suspect were located. The black handgun was found after arrest but was determined to be an airsoft pistol. The officer attempted to apply 941.2965, but later learned it was a forfeiture offense and the City had no adopting language.

Recommendation

To adopt Wis. Stat. 941.2965, Restrictions on Use of Facsimile Firearms, to 9.04.010 of the Wausau Municipal Code.

I recommend a bond amount equal to that of Disorderly Conduct.

Wausau Fire Department Monthly Report

July 2023

Fire Chief Report by Chief Robert Barteck

July was an unusual month with a spike in structure fires. Our crews extinguished 15 structure fires in July. Deputy Chief Kopp's report gets into some of the details about those fires. In other highlights, Division Chief Thompson highlights EMS training and our latest EMS survey results. Division Chief Briggs discusses how the crews have taken advantage of several training opportunities.

Our six paramedic students wrapped up their first semester of studies at the end of July. The class has completed courses in EMS Ops/Fundamentals, Assessment, Pathophysiology, Respiratory, Pharmacology, and Cardiology, including Advanced Cardiac Life Support and Pediatric Advanced Life Support. They will now have a short break from paramedic studies. During that break, they are working a hybrid schedule getting a portion of their firefighting academy completed and will get to work some 24-hour shifts and get on some calls. When they return for the next semester, they will ramp up their clinical time by riding on the med units and spending time in the area emergency departments. It has been exciting to watch them reach such a high level of proficiency in such a short time.

At our monthly leadership meeting, we discussed the pros and cons of a proposal from SAFER for an auto-aid agreement between our departments for structure fire responses. We have a robust Mutual Aid Box Alarm System in Marathon County that each of our departments participates in. An auto-aid agreement would help both departments with increased safety for firefighters and quicker mitigation of structure fires. Our leadership team concluded that we should move forward with researching, developing, and completing an agreement.

On July 10 and 11, we hosted an evaluation team from the Commission on Accreditation of Ambulance Services (CAAS). During the site visit, the team confirmed that we met over 400 benchmark standards for accreditation. It was an intensive two days, and we enjoyed learning from the evaluators. We were thrilled to learn that we earned a perfect score on our application and site visit. The next step is that the CAAS Board will review and vote on our application on August 25. We expect to earn full accreditation status at that time. This is the first time the department has become accredited.

On July 28, we hosted an EMS Roundtable discussion with all the departments that we share mutual aid agreements or have ALS intercept agreements. The roundtable's purpose was to help Mark Lisheron from the Badger Institute with a research article he is working on about rural EMS and potential solutions to problems facing Wisconsin. The meeting was well attended and shed light on many unique aspects of the EMS systems in our region.

The Police and Fire Commission and the Human Resources Director worked quickly after my retirement announcement to post the position. Applications are open until August 7, 2023. As of July 28, the Human Resources Director had received seven applications and expected that number to increase. I hope you find this monthly report informative. Don't hesitate to contact me if you have further questions or want additional information added to this report.



Fire Training Division by Training Division Chief David Briggs

July Scheduled Training:

A brief breakdown of our scheduled activities follows:

- Community Walk-Through
- Forcible Entry
- Haz-Mat Field Survey Instruments

Community Walk-Through

A community "walk-through" does not sound very appealing to some. However, this drill is crucial to ensuring our members become familiar with the district of the city they primarily respond to. Each crew or company was tasked with contacting a local business or businesses to tour and become familiar with their occupancy, safety features, and then discuss how they would react if an incident occurred at the occupancy. Our members really enjoy this assignment as it gets them out in the public, connected with the community, and preparing for the event of a call.

Forcible Entry

Each crew spent time on our home-made forcible entry prop to ensure we can gain access to perform searches, rescues, and fire suppression if faced with a locked door. Some doors are far easier to enter than others, but we train for some of the most difficult circumstances. As we can, we will utilize other props to train on respectful entry or even entry with the use of power tools. This is an imperative skill that is also perishable.

Haz-Mat Field Survey Instruments


Every member of Wausau FD was trained on the use of our metering and monitoring equipment for Hazardous Materials Response in July. Over two thirds of our organization are trained to the Hazardous Materials Technician level and the remainder are at the Operations Level. Each person spent time learning our various devices, their application, and the order in which they should be used. For example, if we do not sample a product's pH first, we could damage other monitors and meters in the process of sampling. We are lucky to have highly skilled Haz-Mat personnel to be able to teach our newer members the ropes in this discipline.

Unassigned Training

Every month, the crews, and companies self-initiate training that they know they need. This flexible time allows them to address topics outside of the assigned schedule.

Not everyone thinks of an incident scene as a training opportunity. However, experiences are invaluable to gain from. The recent barn fire was an opportunity for members to learn how we integrate into a MABAS alarm, how to operate under a larger Incident Command System, water management, resource allocation, and

other concepts. Our members are ready to respond, regardless of the incident. However, when able, we must utilize the opportunity to learn and grow.

Recruit Academy

On July 31st, our cohort of Paramedic students began their fire training academy. During the paramedic program, the students have a three-week break from courses. So, to utilize this time effectively, we gave them a break from EMS and placed them into fire training. Our goal is to have them as prepared as possible to count as staff once they graduate from Paramedic and receive their state licensure. Performing the recruit academy now allows them to transition from paramedic school into our EMS field training sometime in November or December.

Wisconsin Technical College System (WTCS)
Technical Rescue Committee

The WTCS Technical Rescue Committee met in Madison at the state office on July 24th to review three different disciplines. This meeting fine-tuned our final steps to prepare for accreditation for the first Technical Rescue certification in Wisconsin. A goal was set to have all documents for each discipline ready by the end of the year to begin offering the classes after January 1st.

Fire Prevention Division by Fire Marshal Brian Stahl

Inspections: Within the City of Wausau for the month of July, we performed 53 total inspections. We had 12 properties that had Fire Code Violations with 12.5% being Fire Extinguisher Annual Maintenance and 12.5% for annual fire alarm service. These properties will require follow up inspections to confirm compliance. We conducted 3 consultation inspections for the month. One for Fire Suppression systems, one Knox Box, and Site visit for new construction. We also received and recorded 93 reports through the Compliance Engine for services rendered for fire suppression systems at varying businesses.

Investigations: The Prevention Division investigated two fires the month of July. These properties included two separate outbuildings at a residence and a van that was parked at a public property. The van was determined to be accidental forma leaking gas line. The fire at the outbuildings was classified as undetermined with Wausau Police Detectives following up with interviews. The classification "undetermined" is utilized when either two or more competent ignition sources are found or there was no competent ignition source found.

Public Outreach: Throughout July we performed outreach four different times. Two of these were Special event consults, one was for the annual fair safety meeting, and one was for the fairground setup and positioning. One was for a new business that requested an early inspection for future compliance with Fire Inspections. Lastly, we met with the new maintenance at a nursing home to go through disaster planning and explaining the fire departments expectations when dealing with emergencies and fire inspections.

Education: The Prevention Division continued to expand our fire investigation training with the free online portal CFItrainer.com. This website is fully financed through the ATF and supported by the National Fire Academy. These are online, tested classes that can be utilized as continuing education credit towards our Investigation certifications.

Lieutenant Shahn Kariger is again attending the National Fire Academy. Lt. Kariger left on July 29th for the "Community Risk Reduction Program Leader" class. This is a weeklong class starting on Sunday teaching data collection and interpretation standards at the national level. CRR has always been a concern and the Wausau Fire Department has committed to dealing with problem issues and concerns within Wausau. This class will give the Prevention Division the necessary tools to define, collect, analyze, and provide qualitative and quantitative data. This will become more important in the future where just taking our word for it won't be acceptable.

Fire Operations Division by Deputy Chief Jeremy Kopp

Significant calls:

Wow! July was filled with significant calls ranging in nature. Wausau Fire responded to 15 fire calls ranging from cooking fires, vehicle fires, outdoor rubbish fires, an outdoor chair fire, a fire under a rock as well as two residential structure fires next door to each other that are still under investigation. We also sent a fire engine to Rosholt as part of a strike team for a large barn fire. July surely kept the line crews on their toes. The two structure fires seem to have started in one structure and spread to the second structure. The fire is suspicious and under investigation with our fire investigators and police department working together figuring out origin and cause.

Recruitment and Retention:

Researching new ways to recruit is always being looked at and discussed throughout the department, the chiefs and the peer focus group are working together with retention ideas and getting surveys completed to learn more about why people leave and why they stay so we can work on retention strategies. Recruitment talks with the Deputy Chief are still in full force and if you know anyone who may be interested in a career with the Wausau Fire Department, please send them my way for a tour and a chat.

Fleet:

We were approved for the order and purchase of a second new ambulance! The first one should arrive around October or November and the second one should arrive in July of 2024. Ladder 2 suffered a broken outrigger during training and was repaired under warranty work by Custom Fire. We also received news from Fleet supervisor that the 3 new Inspector trucks have landed at the dealership and will be delivered after they are inspected. These three leased vehicles will replace the leased vehicles the inspectors are currently utilizing.

Buildings and Grounds:

We are hopeful that work will be starting soon on the station 3 apparatus bay remodel and landscaping of entire building.





Unhoused Data

The following graph shows the number of unduplicated¹ persons housed by each organization in the previous month.



Unhoused Data by Organization

Unhoused Data Summary

In July, data suggests there were approximately 232 unhoused individuals in Wausau. As indicated in the footnote, 232 is more than the true number of unhoused. As of today, organizations do not crossreference names when coming up with their unduplicated count. This means an unhoused individual may be part of more than one organization's count, thereby inflating the true number of unhoused. An example is provided in the footnote.

In the graph above, 84 percent of the unhoused sought or received shelter in the month of July, 16 percent of the unhoused were living outside, or in places not meant for human habitation.

¹ The numbers reflected do not eliminate duplicates across organizations. For example, a person who stays at Catholic Charities and the Salvation Army in the same month will count as 1 person for each organization.


The Women's Community data includes crime victims who sought shelter because their home was unsafe. This number reflects both single females (19) and their children (10).

Bridge Street Mission includes individuals who have received shelter after release from jail/prison, drug rehab, or homelessness. In previous reports, the number reported to this committee only reflected a small number of individuals who sought shelter in preparation for being transitioned into the "apartments" on the main level of the building. The number reflected should include all individuals who are housed at Bridge Street Mission, because without this amazing program in our community, 33 (per this month's census) individuals would likely be unhoused in our community.

The Marathon County Jail includes individuals who identify as "homeless" or "unhoused" at the time of booking.

Daily Census

We are working hard to collaborate with partner organizations to get a handle on shelter capacity in Wausau. It's important to know if we're meeting or exceeding capacity. The Salvation Army has a capacity of 28. The Warming Center has increased their capacity to 30 but can expand to 40 when temperatures fall below 15 degrees or above 90 degrees. In sum, there is shelter space for 58 individuals on a given night between the 2 organizations.



Daily Census Summary

On average, capacity was at 82 percent for the month of July. The Salvation Army did not reach maximum capacity at all for the month of July. Catholic Charities was at or over their capacity a total of 17 days in the month of July, for a total of 55 percent capacity in July.

Continued collaboration exists to ensure that the unhoused population have access to services during the upcoming summer months.

We continue to work with our partner organizations to learn how many people are turned away each day. In addition to capacity, individuals are turned away for a variety of other reasons. The "turn-away" statistics for the month of July are as follows: Catholic Charities = 33 (13% were turned away due to late arrivals and the remaining 87% were turned away due to shelter capacity) and Salvation Army = 67 (less than 1% turned away due to criminal record, less than 1% turned away due to safety concerns, 19% turned away per Coordinator review, and 70% were turned away due to capacity)

Outreach Update

In July, outreach resulted in 0 individuals receiving housing. Year to date, 31 individuals have been assisted into stable housing. As the reporting remains positive in totality, it is important to note that in the month of July, 1 individual was exited back into homelessness due to eviction.

In addition to assisting with housing, we have also provided additional aid like transportation to medical/psychiatric appointments, bus passes, medication management, collaboration with St. Vincent DePaul, Catholic Charities, and NCCAP. Assistance was also provided with obtaining identification, setting individuals up with additional services through the ADRC as well as Community Treatment through NCHC. Case Management is a service provided through both resources.

Collaboration with landlords and other non-profit agencies is on-going. Office hours at the Marathon County Library twice per week, the Open Door once per week, and one day per week at the Community Partners Campus have proven beneficial in reaching the unhoused population.

Challenges and Opportunities

While we celebrate every time an unhoused individual achieves stable housing, the work does not and cannot end there. Generally, the unhoused population is vulnerable. Without someone providing ongoing support, management, intervention, accountability, and aid, the chances of remaining housed wane dramatically. In other words, our work can and will be undone in short order without systems to sustain the work. Thankfully, there are systems in place, but there are also gaps. Where gaps in case management exist, we are filling that void. We recognize, however, that our time and resources are limited in this regard. As a result, we are working to improve our understanding and relationship with existing systems while also exploring solutions that not only bridge the gap to housing, but to the essential supports that will make housing permanent.

Stories of Success
